And whereas, after the promulgation of NCTE Regulations, 2014, the provisional revised recognition order was issued to the institution on 25.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 (two basic units) from the academic session 2015-16.

And whereas, in compliance of above decision of SRC a letter dt. 22.10.2016 was issued to the institution.

And whereas, the institution vide letter dt. 19.11.2016 and 09.12.2016 requested to close the B.Ed College/Course along with the resolution of society.

And whereas, the matter was considered by the SRC in its 332th meeting held on 28th February to 3<sup>rd</sup> March, 2017 wherein the following was decided:-

- 1. The request for permission to close B.Ed (2 units) is acceptable.
- 2. After they complete the prescribed formalities issue permission for closure of B.Ed (2 units).
- 3. Thereafter, withdraw recognition for B.Ed (2 units) w.e.f. 2017-18.
- 4. Return FDRs, if any.
- 5. Close the file.

And whereas, the decision of SRC was communicated to the institution vide letter dt. 09.03.2017 and the institution had submitted reply vide letter dt. 08.01.2019 along with the following documents:

- 1. Resolution / Extract from the Minutes of the Governing Body Meeting of the managing society.
- 2. No Dues Certificate from the Non-Teaching Staff of the institution.
- 3. No Dues Certificate from the Principal and other faculty of the institution.
- 4. No Objection Certificate dt. 17.12.2018 issued by the Govt. of Pondicherry.

The representation dt. 11.03.2019 of the institution was considered by the SRC in its 373rd Meeting held on 26th & 27th March 2019 it was decided to accord permission to close the institution on the request of the Management.
