WHEREAS, the recognition u/s 14(3)(a) of NCTE Act. 1993 was granted to the institution namely **Dr. Anbupaul College of Education, Anbunagar, Thutipet, Pondicherry-605502** vide order F. PON/SED/N/193/SRO/NCTE/2004-2005/8179 dated 28.10.2004 for conducting Secondary **B.Ed. Course** of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution did not submitted affidavit for its willingness for adherence of provisions of new Regulations and hence, a Show Cause Notice was issued to the institution on 20.05.2016. Thereafter, the institution submitted affidavit dated 30.05.2016 but did not contain the willingness of unit size in B.Ed. programme.
- 3. AND WHEREAS, the SRC in its 397th meeting held on 25th 26th March 2021 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 07.04.2021. The management of the institution has not submitted a reply to the Final Show Cause Notice.
- **4. AND WHEREAS,** the SRC in its 417th Meeting held on 1st & 2nd December, 2022 considered the matter regarding request for closure and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

- (i) The institution failed to submit reply to the Final Show Cause Notice dated 07.04.2021.
- (ii) Further it is also observed that the institution has not filled Performance Appraisal Report (PAR)

Hence the recognition granted **Dr. Anbupaul College of Education, Anbunagar, Thutipet, Pondicherry-605502** for **B.Ed. course** is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e. **2023-2024**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting."

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Dr. Anbupaul College of Education, Anbunagar, Thutipet, Pondicherry-605502** for conducting **B.Ed.** programme of one-year duration with an annual intake of 100 students is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e. **2023-2024**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn.
- **6.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act,1993: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")
