CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, **Sri Vengalamani Amman B.Ed. College, No.167/A, Salem Road, Namakkal District-637001, TamilNadu** vide SRC (NCTE) order no.F.SRO/NCTE/B.Ed./2006-2007/9823 dt. 23.12.2006 conducting Secondary B.Ed. Course of One year duration with an annual intake of 100 students.

2. **AND WHEREAS**, the SRC vide order no. F.No.APS05467/B.Ed./TN/2011-12/47478 dt. 29.11.2012 was issued to the institution for shifting of premises to new location at **Sri Vengalamani Amman B.Ed. College, Nallur, N. Puduppatty Post, Namakkal-637020, Tamilnadu**

3. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 07.03.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 23.03.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

4. **AND WHEREAS**, the matter regarding compliance by the institution of the condition of the revised recognition order, was placed before the SRC in its 381st Meeting held on 31st October, & 01st November, 2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per decision of SRC, a Show Cause Notice was issued to the institution on 20.12.2019. The institution has submitted reply on 24.01.2020.

5. **AND WHEREAS**, on the basis of request, the SRC in its 343rd meeting held on 01st – 02nd July, 2017 decided for reduction of intake from 2 units to 1 unit. Accordingly, a order was issued to the institution on 04.10.2017 reduction of intake from 2 units to 1 unit

6. **AND WHEREAS**, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided to issue Show Cause Notice to all such institutions which have not submitted compliance. Accordingly, as per decision of SRC, a Show Cause Notice was issued to the institution on 16.08.2019. The institution has submitted reply on 13.09.2019.

7. **AND WHEREAS**, the SRC in its 403rd meeting held on 18th & 19th October, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 03.11.2021. The institution has submitted reply on 13.12.2021.

8. **AND WHEREAS**, the SRC in its 405th Meeting held on 13th & 14th December, 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Sri Vengalamani Amman B.Ed. College, Survey No. 260/3M1, 260/3F2, 260/3L, 2603H2, 260/3K2, Nallur, N. Puduppatty Post, Vasanthapuram Village, Namakkal District-637020, Tamil Nadu** for **B.Ed. programme for 1 basic unit of 50 students**".

9. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Sri Vengalamani Amman B.Ed. College, Survey No. 260/3M1, 260/3F2, 260/3L, 2603H2, 260/3K2, Nallur, N. Puduppatty Post, Vasanthapuram Village, Namakkal District-637020, Tamil Nadu** run by **Sri Vengalamani Amman Educational and Charitable Trust, Namakkal District, Tamil Nadu** for Continuation of recognition for B.Ed. programme for two-year duration with annual intake of **1 basic unit of 50 students** subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
11. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with

photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

14. The institution shall make available the list of students admitted on its official website.

15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
