### TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, St. Justins College of Education, No. 161, Kamarajar Salai, Madurai, Tamilnadu-625009 run by Immaculate Conception Education Society, Madurai District, Tamilnadu vide SRC vide order no. F.SRO/NCTE/M.Ed./2006-2007/7685 dt. 09.08.2007 for conducting M.Ed. course of one year duration with an annual intake of 25 (Twenty Five) students.

- 2. AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to St. Justins College of Education, No. 161, Kamarajar Salai, Madurai, Tamilnadu-625009 vide order No. F.SRO/NCTE/2010-2011/20909 dt. 02.09.2010. from the session 2010-2011.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 27.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 25.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.
- 4. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued to the institution on 03.05.2019. The institution did not submit reply to the Show Cause Notice.
- **5. AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 380<sup>th</sup> meeting and the committee decided that Final Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Final Show Cause Notice was issued to the institution on 03.05.2019. The institution has submitted reply on 08.11.2019.
- **6. AND WHEREAS,** the SRC in its 405<sup>th</sup> Meeting held on 13<sup>th</sup> & 14th December, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 08.11.2019. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution submitted faculty list which is sufficient for 1 unit of B.Ed. programme. The institution failed to submit faculty list for 2<sup>nd</sup> Unit of B.Ed., B.Ed. (Add. Intake) and M.Ed. programme as per NCTE Regulations 2014.

2. The institution did not submit form 'A' issued by the bank regarding maintenance of FDRs towards Endowment and Reserve Fund for M.Ed.

programme.

3. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.

Hence, the Committee decided to withdraw the recognition granted to St. Justin's College of Education, 161-A, Kamaraja Salai, Madurai-62509, Tamilnadu for conducting B.Ed. (3 units) & M.Ed. (1 unit) programme programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to St. Justin's College of Education, 161-A, Kamaraja Salai, Madurai-62509, Tamilnadu run by Immaculate Conception Education Society, Madurai District, Tamilnadu-625009 for conducting M.Ed. programme of two years duration with an annual intake of 1 basic unit 50 students with effect from the academic session i.e., 2022-2023 onwards.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
