## TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, Alhaj Abdullah D.Ed. College, Opp. to Bus Stand, Athani, Belgaum District, Karantaka-591304 run by Azad Education Society, Belgaum, Karnataka vide order no. F.SRO/NCTE/D.Ed./2004-2005/9212 dt. 09.12.2004 for Elementary (D.Ed.) course of two and half year's duration from the academic session 2004-05 with an annual intake of 50 students.

- 2. AND WHEREAS, the Southern Regional Committee (SRC) in its 412<sup>th</sup> meeting held on 5<sup>th</sup> & 6<sup>th</sup> July, 2022 took note about non-functioning of the website of the institutions which is mandatory requirement as per NCTE Regulations, 2014. In view of the non-compliance, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institution seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per decision of the SRC, a Show Cause Notice was issued to the institution on 05.08.2022 but the SCN was returned to SRC undelivered with a remark as "ADDRESSEE LEFT, RETURN TO SENDER". The Final Show Cause Notice issued on 02.09.2022. Reply of Show Cause Notice / Final Show Cause Notice has not been submitted by the institution.
- 3. **AND WHEREAS,** the SRC in its 414<sup>th</sup> Meeting held on 26<sup>th</sup> & 27<sup>th</sup> September, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

- (i) The institution failed to submit reply to the Final Show Cause Notice dated 02.09.2022.
- (ii) Further it is also observed that the institution has not filled Performance Appraisal Report (PAR)

Hence the recognition granted to Alhaj Abdullah D.Ed. College, Opp. To Bus Stand, Athani, Belgaum District-591304, Karnataka for D.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e., 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn."

4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdrawing the recognition granted to Alhaj Abdullah D.Ed. College, Opp. to Bus Stand, Athani, Belgaum District-591304, Karnataka run by Azad Education Society, Opp. to Bus Stand, Athani, Belgaum District-591304,

Karnataka for conducting **D.Ed. programme** of two and half years duration with an annual intake of **50 students** with effect from the next academic session i.e., 2023-2024 onwards.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(5. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

- 6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
