WHEREAS, you have applied for grant of recognition to Repalle Christina College of Education, Repalle - 522265, Guntur District, Andhra Pradesh for B.Ed. Course of one year duration from the academic session 2001-2002 to the Southern Regional Committee on 18.12,2000.

AND WHEREAS, the recognition of the institution namely Repalle Christian College of Education, Reppalle, Guntur-522265, Andhra Pradesh was refused vide SRC (NCTE) order no. F.AP/NEW/B.ED/77/SRO/NCTE/2002-2003/6691 dt.04.04.2008 for conducting B.Ed. course of one-year duration.

AND WHEREAS, aggrieved by the refused order, the institution preferred an appeal to NCTE-Hqrs. The Appellate Authority in its order vide letter no. F.No. 42-42/2002/Appeal/27317 dated 31.12.2002 the Council hereby reverses the Orders appealed against by granting recognition to Repalle Christian College of Education, Reppalle, Guntur-522265, Andhra Pradesh.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 21.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, the SRC in its 284th meeting held on 09th - 10th April, 2015 considered the matter and decided to issue Notice under section 14 of NCTE act. Accordingly, as per the decision of SRC a notice was issued to the institution on 28.04.2015.

AND WHEREAS, as per RPRO vide order no. F.SRO/NCTE/APS00016/B.Ed/AP/2015-16/65537 dated 26.05.2015 on scrutiny it is found that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 04.04.2003.

AND WHEREAS, as per the decision 369th Meeting of SRC held on 28.01.2019 a Show Cause Notice to be issue to all such institution which have not submitted compliance. Accordingly, a show cause notice was issued to the institution on 30.04.2019. The institution has not submit the show cause notice reply till date.

AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov. 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents. As per the decision of SRC a final show cause notice was issued to the institution on 20.11.2019. The institution vide letter dated 12.12.2019 received on 18.12.2019 submitted its reply to the final show cause notice along with the documents.

AND WHEREAS, the SRC in its 387th Meeting held on 24th - 25th August, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution on 18.12.2019. The Committee observed and found the following deficiencies: -

- 1. The recognition was granted to the institution on rented premises "India Rural Evangelical Fellowship, Repalle-522265, Guntur District, Andhra Pradesh". The institution has not shifted its institution to own permanent building which is a violation of the NCTE Regulations 2002, 3(c).
- 2. Percentage of marks in M.Ed. of Principal is less than 55%.
- 3. The institution has not appointed faculty for Performing Arts.
- 4. Lecturer from S.No. 10 to 16 have been shown appointed on 01.04.2018, thus not having NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017. Other staff have been shown appointed before promulgation of NCTE Regulations dated 09.06.2017.
- 5. Built up area and site area not mentioned in building plan.
- 6. The survey no. mentioned in building plan, site plan, BCC is 463/1A whereas the survey nos. mentioned in the land document are 463/1A, 342/11, 464/1, 463/2, 338/17, 18, 18B, 335, 342/3. The institution is required to clarify about the different survey no. in land and building documents.
- 7. Building plan and site plan does not show site area and built-up area. Multipurpose hall area
- 8. The survey no. mentioned in the land documents submitted at the time of recognition is different from the survey no. mentioned in the land documents submitted now.

Hence, the Committee decided to withdraw the recognition granted to Repalle Christian College of Education, Reppalle, Guntur-522265, Andhra Pradesh for conducting B.Ed. course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Repalle Christian College of Education, Reppalle, Guntur-522265, Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of 100 students (2 units) w.e.f. the next academic

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
