WHEREAS, the recognition was granted to the institution namely Hailee College of Education, Dharmavaram Revenue Division, Kalyandurgam, Anantapur Dt-515671, Andhra Pradesh run by Socio Economic Education Christian Development Society, Kalyandurgam, Anantapur District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/111/SRO/NCTE/2003-2004/530 dt 23.12.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2003-2004.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 28.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 (One basic unit) from the academic session 2015-16.

AND WHEREAS, the SRC issued a Corrigendum vide order no. F.SRO/NCTE/APSO0209 /B.Ed/AP/2015/ 77109 dt. 27.10.2015 permitted the institution for one basic unit.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 06.03.2019. The institution did not reply to Show Cause Notice till date.

AND WHEREAS, the Sub-Committee of the SRC in 380th meeting decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 15.10.2019. The institution vide letter dated 01.11.2019 submitted its reply to the final show cause notice along with the documents.

AND WHEREAS, the SRC in its 383rd Meeting held on 7th, 8th and 9th January 2020 considered the matter and decided as under:-

The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 06.03.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 15.10.2019. The institution vide letter dated 01.11.2019 submitted its reply/representation in response to Final Show Cause Notice FSCN). On perusal of the same the Committee found the following defects/ shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under:-

- (i) The building plan submitted by the institution is not duly approved and there is no evidence of permanent building.
- (ii) The institution submitted notarized copy of building plan in the name of Hailee Institute of Education and Training, Kambadur Road, Kurarala Palli, Near Kalyandurg approved by Sarpanch, Grama Panchayath, Badrahalli The Size of the Multipurpose Hall not mentioned in the Building plan
- (iii) The institution has not appointed the faculty of Performing Arts.

Hence, the Committee decided to withdraw the recognition granted to Hailee College of Education, Dharmavaram Revenue Division, Kalyandurgam, Anantapur Dt-515671, Andhra Pradesh for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Hailee College of Education, Dharmavaram Revenue Division, Kalyandurgam, Anantapur Dt-515671, Andhra Pradesh run by Socio Economic Education Christian Development Society, Kalyandurgam, Anantapur District, Andhra Pradesh for conducting B.Ed. programme of two years duration with an annual intake of 50 students (1 unit) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
