WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely K.C. Narayana College of Education, Ananthapur District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/130/NCTE/2002-2003/6127 dt 28.02.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, as per VT Report received on 10.06.2002 (before grant of recognition), the institution is functioning in leased premises.

AND WHEREAS, a letter was issued to the institution regarding submission of documents with respect to shifting of premises on 01.06.2009. As per PARs submitted by the institution and the reply of the institution dated 24.06.2009, the institution is functioning in its own building.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 24.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic unit) from the academic session 2015-16.

AND WHEREAS, on 30.07.2015, a letter along with compliance report and some documents is received by this office from the President / Correspondent, K. C. Narayana College of Education. The SRC in its 315th meeting held during 17th to 18th June, 2016 considered the matter and decided to issue show cause notice. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 04.07.2016. On 25.07.2016, a reply to the show cause notice was received by the institution.

AND WHEREAS, the SRC in its 320th meeting held during 19th to 20th September, 2016 considered the matter and decided to issue show cause notice. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 27.10.2016. The institutions vide letter dated 07.11.2016 submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 343rd meeting held during 1-2 August, 2017 considered the matter and decided as under:-

1. There are RPRO cases. In view of the latest instructions, no inspection is required in these.
2. But, these also involve 'shifting'.
Therefore, VT Inspection will be required.
3. The SRO's request is noted and permission is given for organizing VT Inspections in these cases.

AND WHEREAS, the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per the decision of SRC a First Show Cause Notice was issued on 20.11.2019. The institution vide letter dated 11.12.2019 submitted reply to the first Show Cause Notice

AND WHEREAS, the SRC in its 387th Meeting held on 24th – 25th August, 2020 considered the matter and decided as under:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and representation of the institution for closure of B.Ed. course, the following observations were made: -

The Committee decided to withdraw the recognition granted to K.C Narayana College of Education, Anantapur Revenue Division, Hanumesh Nagar, Guntakal, Anantapur District-515801, Andhra Pradesh for conducting B.Ed course under clause 17(1) of NCTE Act, 1993 on its own request made vide letter dated 11.12.2019. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

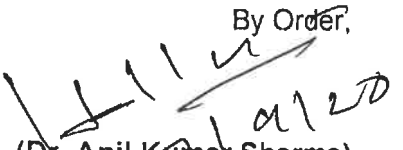
NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of K.C. Narayana College of Education, Anantapur District, Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of 100 students (2 units) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school,

College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
