WITHDRAWAL ORDER

WHEREAS, Recognition was granted to the institution namely **Hussainy College of Education, Venkatampeta, Dattalur Mandal, Nellore District-524230, Andhra Pradesh** run by **Hussainy Educational Society, Nellore, Andhra Pradesh** vide SRC (NCTE) order no. F.AP/B.Ed/NEW/64/SRO/NCTE/2000-2001/6267 dt. 04.04.2001 for conducting B.Ed. course of one-year duration with an annual intake of 120 students from the academic session 2000-2001.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt. 20.01.2015 for its willingness for adherence of provisions of new Regulations. A Provisional Revised Recognition Order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 01.03.2019. The institution vide letter dated 30.03.2019 submitted reply to the show cause notice

AND WHEREAS, the SRC in its 378th meeting held on 25th – 26th July, 2019 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 30.07.2019. The institution vide letter dated 30.08.2019 submitted reply to the Final Show Cause Notice. The SRC in its 382nd meeting held on 26th – 27th November, 2019 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee perused the original file and the record made available, the Committee observed that the institution sought 90 days time to submit the reply to SCN. The same is not accepted by the SRC.

Hence, the Committee decided to **withdraw the recognition** granted to **Hussainy College of Education, Venkatampeta, Dattalur Mandal, Nellore District-524230, Andhra Pradesh** for conducting B.Ed. course w.e.f. the next academic session 2020-21 under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Hussainy College of Education, Venkatampeta , Dattalur Mandal, Nellore District-524230, Andhra Pradesh** run by **Hussainy Educational Society, Nellore, Andhra Pradesh** for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
