WHEREAS, the recognition was granted to the institution namely Ramaraja Womens College of Education, 18-1-90/14/4, Yashoda Nagar, Chittoor, Thirupati-517507, Andhra Pradesh run by Little Angels Educational Society, D.No. 18-1-90/12G, Yashoda Nagar, K.T. Road, Tirupati- 517507, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/228/SRO/ NCTE/2002-2003/6689 dt. 04.04.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, the SRC in its 201st meeting held on 22-23 February, 2011 considered the written representation from the institution dated 11.02.2011 to the show cause notice and all other documentary along with the original file of the institution and decided that shifting to new/permanent premises be permitted to Ramaraja College of Education, 18-1-90/14/4, Yashoda Nagar, Chittoor, Thirupathi-517507, Andhra Pradesh with an annual intake of 100 for offering B.Ed course.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 27.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a revised provision recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 200 (four basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th meeting held on 28.01:2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 30.04.2019. The institution did not reply to the show cause notice till date.

AND WHEREAS, the Sub-Committee of the SRC in 380th meeting decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly as per the decision of SRC a Final Show Cause Notice was issued to the institution on 11.10.2019. The institution vide letter dated 25.10.2019 submitted its reply to the final show cause notice along with the documents.

AND WHEREAS, the SRC in its 384th Meeting held on 12th and 13th February 2020 considered the matter and decided as under:-

The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 30.04.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 25.10.2019 submitted letter dated institution vide 11.10.2019. The

reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under: -

- (i) The institution submitted Notarized photocopy of site plan in the name of Ramaraja College of Education (B.Ed) & Ramaraja Teacher Training Institute (D.Ed), Yashoda Nagar, Tirupati, Chittoor Dist., AP which is not approved by competent authority.
- (ii) One lecturer does not possess required percentage in PG.

Hence, the Committee decided to withdraw the recognition granted to Ramaraja Womens College of Education, 18-1-90/14/4, Yashoda Nagar, Chittoor, Thirupati-517507, Andhra Pradeshfor conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Ramaraja Womens College of Education, 18-1-90/14/4, Yashoda Nagar, Chittoor, Thirupati-517507, Andhra Pradesh run by Little Angels Educational Society, D.No. 18-1-90/12G, Yashoda Nagar, K.T. Road, Tirupati- 517507, Andhra Pradesh for conducting B.Ed. programme of two years duration from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
