WHEREAS, as per the order No. F.No.89-98/2003/Appeal dated 19.08.2003 issued by the Appellate Authority, the institution namely Allen Alfred College of Education, Hyderabad, East Revenue Division, Rangareddy District- 500060, Telangana run by Allen Alfred Educational Society, Flat No. 306, Nutan's Ramya AptsGaddiannaram, Dilsukhnagar, Hyderabad, Telangana was granted recognition for conducting B.Ed. course of one-year from the academic session 2002-2003.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt.02.02.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, thereafter, provisional revised recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, as per the decision of SRC a Show Cause Notice was issued to the institution on 12.10.2018 which is returned back to the SRC office. Another Show Cause Notice vide dt. 01.03.2017 was the institution. The institution did not reply to the show cause notice till date.

AND WHEREAS, the SRC in its 380th meeting held on 18th and 19thSeptember, 2019 considered the matter and decided to issue Final SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a Final Show Cause Notice was issued to the institution on 25.09.2019 The institution did not reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 383rd Meeting held on 7th, 8th and 9th January 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

(i) The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 01.03.2017. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 25.09.2019. The institution did not submit its reply/representation in response to Final Show Cause Notice (FSCN).

(ii) The Registrar, Osmania University, Hyderabad vide letter No. 1554-MR/H/B.Ed/2019-2020/Acad/IV-2 dated 11.12.2019, has informed that the University has discontinued the extension of affiliation from the academic year 2015-2016 in respect of the institution Allen Alfred College of Education, Hyderabad, East Revenue Division, Rangareddy District-500060, Telangana"

Hence, the Committee decided to withdraw the recognition granted to Allen Alfred College of Education, Hyderabad, East Revenue Division, Rangareddy District- 500060, Telanganafor conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
