WITHDRAWAL ORDER

2 1 FEB 2020

WHEREAS, recognition was granted to the institution namely Lisieux College of Education, Sathy Main Road, Saravanampatty, Coimbatore-641035, Tamilnadu vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/9620 dated 14.12.2006 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2006-2007.

AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the NCTE Act, 1993 (73 of 1993) the NCTE (Recognition Norms and Procedure), Regulations, 2014 were notified on 01.12.2014 in supersession of the NCTE (Recognition Norms and Procedure), Regulations, 2009.

AND WHEREAS, after promulgation of NCTE Regulations, 2014, the duration of the B.Ed. course was increased from one year to two years and the existing institutions offering B.Ed. course, of one-year duration, were required to give their acceptance, in the form of an affidavit, for adherence of the NCTE Regulations, 2014.

AND WHEREAS, after promulgation of NCTE Regulations, 2014 and as per affidavit submitted by the institution dt. 28.01.2015, the Revised Provisional Recognition Order was issued to the institution on 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students each for (two basic units) from the academic session 2015-16 subject to fulfilment of the conditions mentioned therein.

And whereas, the SRC in its  $384^{th}$  meeting held on  $12^{th} - 13^{th}$  February, 2020 considered the matter and decided as under:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 15.02,2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 03.12.2019. The institution vide letter dated 12.12.2019 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects/shortcomings/deficiencies as per provisions of the NCTE Regulations, 2014 which are as under:

- 1. The Land was taken on Lease from private party for 55 years vide lease deed dt. 22.03.2010 but the same is not permissible under NCTE Regulations.
- 2. The institution submitted a photocopy of notarized copy of Land Use Certificate of dt.28.02.2008 certified by Member Secretary, Coimbatore Local Planning Authority. The LUC Can not be accepted on the face of the deficiency of Land Documents.

3. The institution submitted NEC in Regional Language. The institute also submitted the notarized English Translation. The NEC Can not be accepted on the face of the deficiency of Land Documents.

4. The institution submitted photocopy of Building Plan. The Building Plan Can not be

accepted on the face of the deficiency of Land Documents.

5. The institution had submitted photocopy of BCC. The BCC can not be accepted on the face of the deficiency of Land Documents.

Hence, the Committee decided to withdraw the recognition granted to Lisieux College of Education, Sathy Main Road, Saravanampatty, Coimbatore-641035, Tamilnadu for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

Now therefore, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Lisieux College of Education, Sathy Main Road, Sarayanampatty, Coimbatore-641035, Tamilnadu vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/9620 dated 14.12.2006 for conducting B.Ed. course of one year duration with an annual intake of 100 students from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an appeal u/s 18 of the NCTE Act, 1993, through "Online mode" available on NCTE's website www.nete-india.org, within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
