WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely Kolandhavel Teacher Training Institute, Thippampatti Post, Pollachi Taluk, Coimbatore District, Tamilnadu - 642107 vide SRC (NCTE) order no. F.SRO/NCTE/D.T.Ed./2006-2007/18877 dated 19.03.2008 for conducting D.T.Ed. course of two-years duration with an annual intake of 50 students.

AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the NCTE Act, 1993 (73 of 1993) the NCTE (Recognition Norms and Procedure), Regulations, 2014 were notified on 01.12.2014 in supersession of the NCTE (Recognition Norms and Procedure), Regulations, 2009.

And whereas, a letter dt.12.02.2019 has been received from the institution with the request to withdraw the recognition of course along with the following documents:

- 1. Application for closure
- 2. Resolution of the Trust
- 3. Certificate for Relieving Order of faculties
- 4. Certificate for cash payment towards Salary to faculty.

And whereas, the SRC in its 384^{th} meeting held on $12^{th} - 13^{th}$ February, 2020 considered the matter and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

The Committee decided that to withdraw the recognition granted to Kolandhavel Teacher Training Institute, Thippampatti Post, Pollachi Taluk, Coimbatore District, Tamilnadu – 642107for conducting D.T.Ed course under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 12.02.2019. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

(a) NOC from the affiliating body.

(b) NOC from the staff/faculty.

(c) Resolution of the management to the effect for closure of the course."

Now therefore, in exercise of the powers vested u/s 17(1) of the NCTE Act. 1993, the Southern Regional Committee hereby Kolandhavel Teacher Training Institute, Thippampatti Post, Pollachi Taluk, Coimbatore District, Tamilnadu – 642107 vide SRC (NCTE) order no. F.SRO/NCTE/D.T.Ed./2006-2007/18877 dated 19.03.2008 for conducting D.T.Ed. course of two-years duration with an annual intake of 50 students from the next academic session starts after issuance of this order. Permission granted vide order no. F.SRO/NCTE/D.T.Ed./2006-2007/18877 dated 19.03.2008.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an appeal u/s 18 of the NCTE Act, 1993, through "Online mode" available on NCTE's website www.ncte-india.org, within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
