WITHDRAWAL ORDER UNDER SECTION 17 OF NCTE ACT, 1993

Whereas, recognition was granted to the institution namely Raj College of Education, No.385C, Harveypatty, Thirupparankundram Post, Madurai-625005, Tamilnadu vide SRC (NCTE) order no. F.SRO/NCTE/2009/B.Ed./2006-2007/14076 dt.02.11.2007 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2006.

And whereas, permission to shift the institution at the new location was granted vide order dt. 15.11.2011.

And whereas, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt.06.05.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

And whereas, provisional revised recognition order was issued to the institution on 22.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

And whereas, the institution submitted a letter dt. 27.10.2017 inter-alia requesting for closure of B.Ed. Course.

And whereas, the matter was considered by the SRC in its 365th meeting held on 31st October to 1st November, 2018 wherein the Committee the decided the following:-

- 1. This is a closure case.
- 2. They have not submitted the documents required.
- 3. Ask them to submit.
- 4. Thereafter, put up for permitting closure.5. If they do not give the documents. Put up for considering closure independently.
- 6. But FDRs will be returned only when they complete the formalities.

And whereas, the above decision of SRC was communicated to the institution vide letter dt. 20.11.2018.

And whereas, the institution has not submitted any reply and institution has again requested for closure of course and return of FDRs vide letter dt. 04.01.2019.

And whereas, the matter was considered by the SRC in its 376th meeting held on 11th - 12th June, 2019. The decision of SRC is reproduced below :-

"The Committee decided to withdraw the recognition of B.Ed. course and ask the institution to follow the procedure of closure norms."

Now therefore, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Raj College of Education, No.385C, Harveypatty, Thirupparankundram Post, Madurai-625005, Tamilnadu was granted recognition vide SRC, NCTE's vide order no. F.SRO/NCTE/2009/B.Ed./2006-2007/14076 dt.02.11.2007 and vide revised recognition order no.:F.SRO/NCTE/APSO6108/B.Ed./TN/2015-16/65303 dt.22.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 students (two units) from the next academic session commences after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (I) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website <u>www.ncte-india.org</u>, within 60 days from the date of issue of this Order. The guidelines for filling appeal may be seen on NCTE's website.
