WHEREAS, the recognition was granted to the institution namely Residency College of Education, H.No.4/21, Main Road, Rajampet, Kadapa-516126, Andhra Pradesh run by Residency Educational Society, Kadapa District, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2007-2008/2290 dt. 28.09.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

**AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 19.01.2015 for its willingness for adherence of provisions of new Regulations.

**AND WHEREAS**, thereafter, provisional revised recognition order was issued to the institution on 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 18.02.2019. The institution did not reply to the show cause notice till date.

AND WHEREAS, the Sub-Committee of the SRC in 380<sup>th</sup> meeting decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, a Final Show Cause Notice was issued to the institution on 14.10.2019 the institution vide letter dated 23.10.2019 submitted its reply to the final show cause notice along with the documents.

AND WHEREAS, the SRC in its 383<sup>rd</sup> Meeting held on 7<sup>th</sup>, 8<sup>th</sup> and 9<sup>th</sup> January 2020 considered the matter and decided as under:-

The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 18.02.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 14.10.2019. The institution vide letter dated 23.10.2019 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under:-

(i) The institution submitted photocopies of building plan in the name of Residency Educational Society, Tallapaka Cross Road, Behind Annamaiah Statue, Peddakarampalli (G.P.), Rajampet Mandal, Y.S.R. Kadapa District, AP which is not approved by competent authority, Size of Multipurpose Hall not mentioned in the Building plan

- (ii) Site Plan submitted by the institution is not approved by the competent authority.
- (iii) The Committee also observed that the institution was granted recognition in the year 2007. In response to Final Show Cause Notice (FSCN) the institution submitted land & building documents which are altogether different. The Management has never applied for shifting of the premises. Even the staff list submitted is not in prescribed format and now where the competent authority could affix the date.

Hence, the Committee decided to withdraw the recognition granted to Residency College of Education, H.No.4/21, Main Road, Rajampet, Kadapa-516126, Andhra Pradesh for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
