WITHDRAWAL ORDER**

WHEREAS, recognition was granted to the institution namely **Sri Venkateshwara B.Ed College, 12-3-418-2, Jesus Nagar, Anantapur-515001, Andhra Pradesh** run by **Sri Venkateshwara Educational Society, Ananthpur, Andhra Pradesh** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/5386 dt 26.06.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2006-2007.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 29.01.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 (One basic unit) from the academic session 2015-16.

AND WHEREAS, the SRC in its 368th meeting held during 08th – 09th January, 2019 considered the matter and decided to issue SCN. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 17.01.2019. **The institution did not reply to Show Cause Notice till date.**

AND WHEREAS, a Final Show Cause Notice was issued to the institution on 10.10.2019. The institution vide letter dated 01.11.2019 submitted its reply to the Final Show Cause Notice. The SRC in its 382nd meeting held on 26th – 27th November, 2019 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided that to **withdraw the recognition** granted to **Sri Venkateshwara B.Ed College, 12-3-418-2, Jesus Nagar, Anantapur-515001, Andhra Pradesh** for conducting B.Ed. course under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 01.11.2019. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.

(c) Resolution of the management to the effect for closure of the course

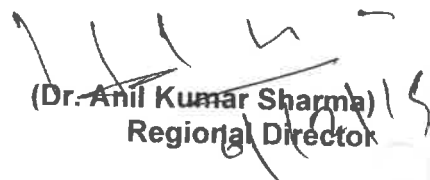
NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Sri Venkateshwara B.Ed College, 12-3-418-2, Jesus Nagar, Anantapur-515001, Andhra Pradesh** run by **Sri Venkateshwara Educational Society, Ananthpur, Andhra Pradesh** for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
