WHEREAS, Recognition was granted to the institution namely Master College of Education, S.No. 316/2, Tetail Village, Tanuku Mandal, West Godavari District-534211, Andhra Pradesh run by Krishna Veni Educational Society Godavari District, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/2395 dt. 09.05.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2007-2008.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 23.1.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, thereafter, provisional revised recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

**AND WHEREAS**, on the basis of requested the SRC in Its 342<sup>nd</sup> meeting decided for reduction of intake from 2 units to 1 unit. Accordingly a order dated 21.07.2017 was issued.

AND WHEREAS, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 27.03.2019. The institution did not reply to the show cause notice.

AND WHEREAS, the matter was further considered by the Sub-committee constituted by the SRC as per its decision taken in 380<sup>th</sup> meeting. The Sub-Committee of the SRC decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the Institution. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 15.10.2019. The institution did not reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 383<sup>rd</sup> Meeting held on 7<sup>th</sup>, 8<sup>th</sup> and 9<sup>th</sup> January 2020 considered the matter and decided as under:-

(i) The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 27.03.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 15.10.2019. The institution did not submit its reply/representation in response to Final Show Cause Notice (FSCN).

Hence, the Committee decided to withdraw the recognition granted to Master College of Education, S.No. 316/2, Tetail Village, Tanuku Mandal, West Godavari District-534211, Andhra Pradeshfor conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order.
