WHEREAS, the recognition was granted to the institution namely Montessori College of Education, No. 1-48-11, Beside APHB Colony, Tadepalligudem, West Godavari District-534101, Andhra Pradesh run by M.V.R. Educational Society, West Godavari Dist, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2007-2008/13317 dt. 23.10.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 02.02.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a revised provisional recognition order was issued to the institution on 27.04.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 363rd meeting held on 17th and 19th September, 2018 and the Committee decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on. 12.10.2018.

AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov, 2019 decided to issue Final Show Cause Notice to all such institution where reply of SCN has not been submitted by the institution. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 07.11.2019. The institution submitted reply to the Final Show Cause Notice along with a letter on 14.11.2019.

AND WHEREAS, the SRC in its 384th Meeting held on 12th and 13th February 2020 considered the matter and decided as under:-

The Management of the Institution had not submitted required documents in response to letter issued to the Institution on 12.10.2018. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 07.11.2019. institution vide letter dated 14.11.2019 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found that the institution has not submitted requisite documents mentioned in Show Cause Notice & Final Show Cause Notices.

Hence, the Committee decided to withdraw the recognition granted to Montessori College of Education, No. 1-48-11, Beside APHB Colony, Tadepalligudem, West Godavari District-534101, Andhra Pradesh for conducting B.Ed course w.e.f. the next

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Montessori College of Education, No. 1-48-11, Beside APHB Colony, Tadepalligudem, West Godavari District-534101, Andhra Pradesh run by M.V.R. Educational Society, West Godavari District, Andhra Pradesh for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
