Recognition was granted to the institution namely Sri Sai Baba National D.Ed College, Khasra No. 2019-2 & 2025-2, Plot No. 153, Opp. ZP Office, Anantapur Village and post Office, Anantapur Taluk and Town, Anantapur District-515001, Andhra Pradesh run by The Anantapur District National Education Trust, Plot No. 153, Opp. Z.P.Office, Hospital Road, Anantapur Town and Post Office, Ananthpur District Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/D.El.Ed/AP/2016/87326 dt. 13.07.2016 for conducting D.El.Ed. course of one-year duration with an annual intake of 50 students from the academic session 2017-2018.

The institutions vide letter date 28.12.2019 submitted a written representation stating as under:-

"...With reference to the above we wish to bring to you kind notice that the courses (B.Ed and D.E.Ed) have not been in operation since 2016-18 academic year for want of student strength.

So, we request you to windup the B.Ed. and D.El.Ed Courses as they are not viable for continuation. We also request you to permit us to withdraw Endowment Found and Reserve Funds. This is for your kind information and necessary action".

AND WHEREAS, the SRC in its 383rd Meeting held on 7th, 8th and 9th January 2020 considered the matter and decided as under:-

The Committee decided that to withdraw the recognition granted to Sri Sai Baba National D.Ed College, Khasra No. 2019-2 & 2025-2, Plot No. 153, Opp. ZP Office, Anantapur Village and post Office, Anantapur Taluk and Town, Anantapur District-515001, Andhra Pradeshfor conducting D.El.Edcourse under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 28.12.2019. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- NOC from the affiliating body. (a)
- NOC from the staff/faculty. (b)
- Resolution of the management to the effect for closure of the course (c)

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
