WHEREAS, The recognition was granted to the institution P. Narayana Reddy College of Education, No. 420, 450, Plot No. 4,2nd Street, Pebbair Village, Post, Taluk & City, Mahbubnagar District-509104, Telangana run by Vishvabharathy Educational Society, No.9-26/1, Wanaparthy Road, Pebbair Village, Post, Taluk & City, Mahbubnagar District-509104, Telangana vide SRC (NCTE) order no. F.SRO/NCTE/SRCAPP3195/B.Ed/AP/2016-2017/84811 dt. 12.05.2016 for conducting B.Ed programme of two years duration with an annual intake of 100 students (2 unit) from the academic sessions 2016-2017.

AND WHEREAS, a letter No. 4957/SE.Trg/A2/2016-5 dated 12.09.2018 received on 09.10.2018 from Special Chief Secretary to Govt., School Education Department, Government of Telangana. The details as under;

"Your attention is invited to the reference 1st cited (copy enclosed), wherein the NCTE, SRC was requested to withdraw the Recognition given to P. Narayana Reddy College of Education, Pebbair Village, Post, Taluk & City, Mahbubnagar District-509104(now Wanaparthy District), for conducting B.Ed programme of (2) years, informing about non fulfillment of the NCTE, SRC, regarding these deficiencies pointed out by the Government and action take thereon is received so far.

- 2. In this regard, it is to inform further that in the reference 3rd cited, a report is received informing that four faculty members of this College are also working in other Colleges. They are (1) Sri A. Shankaraiah Goud, Lecturer in Psychology duplicated as Lecturer in Social Studies at Vishvabharathy District (2) Sri M. Kuru Murthy, Lecturer in English duplicated at Vishvabharathy College of Elementary Education, Pebbair Village & Mandal, Wanaparthy District (3) Sri T. Venkatesh, Lecturer in Physical Education duplicated as Lecturer in Physical Education at Vishvabharathy College of Elementary Education, Pebbair Village & Mandal, Wanaparthy District (4) Sri Md. ShamseeVur Rahman, Lecturer in Mathematics duplicated as Lecturer in Maths at Manasa College of Elementary Teacher Education, Kothakota Village & Mandal, Wanaparthy District.
- 3. Thus, P. Narayana Reddy College of Education, Pebbair Village, Post, Taluk & City, Mahbubnagar District-509104(now Wanaparthy District), has seriously violated the NCTE norms. In the college recognition order of the NCTE Gazette order dtd. 02.05.2016, it is clearly mentioned that "If the institution Contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made of issued thereunder, the institution will render itself vulnerable to adverse action including

4. Hence, considering the above facts and also the deficiencies already pointed out in the letter 1st cited, it is once again requested to withdraw the Recognition given to, P. Narayana Reddy College of Education, Pebbair Village, Post, Taluk & City, Mahbubnagar District-509104(now Wanaparthy District), for conducting B.Edprogramme of (2) years, at the earliest."

AND WHEREAS, another letter No. G.O.Rt. No. 117, dated 01.10.2018 received on 09.10.2018 from Smt. Ranjeev R. Acharya, I.A.S, Special Chief Secretary to Govt., Education Department, Government of Telangana. The details as under;

"In the reference 1st res above, the National Council for Teacher Education (Southern Regional Committee), Bengaluru, granted recognition to P. Narayana Reddy College of Education, Pebbair Village, Post, Taluk & City, Mahbubnagar District-509104(now Wanaparthy District), Telangana State for conducting B.Ed programme of two years duration with an annual intake of 100 students (1 unit) from the academic sessions 2016-2017, subject to the fulfilment of certain conditions.

- 2. In the reference 2nd read above, the President, P. Narayana Reddy College of Education, Pebbair Village, Post, Taluk & City, Mahbubnagar District-509104(now Wanaparthy District) has requested for orders to start a new B.Ed college P. Narayana Reddy College of Education, Pebbair, Mahbubnagar District(now Wanaparthy District).
- 3. In the reference 3rd read above, the Commissioner& Director of School Education, Telangana, Hyderabad, gave a report that no faculty member is having (3) years of teaching experience in the institution as per norms and no administrative and professional staff are provided such as Librarian, Lab-Assistant, Office-cum-Accounts Assistant; Technical Assistant, Lab Attendant etc. Moreover, no play equipment's are provided, and it has no facilities to safeguard against Fire hazard. Similarly, other facilities required as per norms such as Photocopying: Computers with internet, Furniture, Teaching Learning Resource Centre for Art and Word Experience are also not provided.
- 4. In the reference 4th read above, the Government informed Regional Director, National Council for Teacher Education (NCTE), Southern Reginal Committee (SRC), Bengaluru regarding the deficiencies in respect of P. Narayana Reddy College of Education, as mentioned in Pare-3 above with a request to withdraw the recognition given to P. Narayana Reddy College of Education as per the NCTE norms that "If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act." This was also done in pursuance of the Hon'ble High Court observations in the orders dtd. 06.01.2017 in Writ Appeal No. 1047/2016 and batch that "Even if the State intends to express any grievance as to non-compliance of any one of the conditions required under the Norms, the State ought to have brought the same to the notice of the NCTE and ought to have sought appropriate action against the society/college, which the State has not resorted to."

- 5. In the reference 5th read above, the Hon'ble High Court allowed the W.P.No.10597/2018 filed by P. Narayana Reddy College of Education, Pebbair Village, Post, Taluk & City, Mahbubnagar District-509104(now Wanaparthy District), Telangana State by Interim Order dtd. 09.04.2018 in IA Nos.1 & 2 of 2018 in W.P.No.10597 of 2018, with a direction to the respondents to grant affiliation to the college and to issue a G.O. subject to the decision of the NCTE on the letter dtd. 07.04.2018 addressed by the Special Chief Secretary to Government, School Education Department to the Regional Director and OSD Headquarters, National Council for Teacher Education NCTE, Southern Regional Committee, Bangalore.
- 6. In the reference 6th read above, the Commissioner & Director of School Education, Telangana, Hyderabad, gave a further report that four faculty members of the P. Narayana Reddy College of Education are duplicated in other Colleges. They are (1) Sri A. Shankaraiah Goud, Lecturer in Psychology duplicated as Lecturer in Social Studies at Vishvabharathy District (2) Sri M. Kuru Murthy, Lecturer in English duplicated at Vishvabharathy College of Elementary Education, Pebbair Village & Mandal, Wanaparthy District (3) Sri T. Venkatesh, Lecturer in Physical Education duplicated as Lecturer in Physical Education at Vishvabharathy College of Elementary Education, Pebbair Village & Mandal, Wanaparthy District (4) Sri Md. ShamseeVur Rahman, Lecturer in Mathematics duplicated as Lecturer in Maths at Manasa College of Elementary Teacher Education, Kothakota Village & Mandal, Wanaparthy District.
- 7. In the reference 7th read above, in addition to the deficiencies already pointed in the refence 4th read above, the Government informed Regional Director, National Council for Teacher Education (NCTE), Southern Regional Committee (SRC), New Delhi regarding the deficiencies as mentioned in para-6 above and one again requested to withdraw the recognition given to P. Narayana Reddy College of Education as per the NCTE norms.
- 8. In the reference 8th read above, a Show Cause Notice dtd. 31.8.2018 in C.C. No.2307/2018 was received by the Government from the Hon'ble High Court posting the case on 19.9.2018. A detailed Counter Affidavit was filed in the C.C No. 2307/2018 by the State Government on 17.09.2018.
- 9. In the reference 9th read above, the Government Pleader for Education, High Court, Hyderabad has informed that the Contempt Case No.2307/2018 came up before the Hon'ble High Court on 24.09.2018 and the Hon'ble High Court posted the Case on 04.10.2018 for compliance of Interim orders dtd. 09.04.2018 in IA Nos.1 & 2 of 2018 in W.P.No.10597 of 2018 and requested to submit compliance report so as to place before the Hon'ble Court on 04.10.2018.
- 10. Hence, after careful examination of the matter and in pursuance of the orders of the Hon'ble High Court in the reference 5th read above and the recognition given by the National Council for Teacher Education, Bengaluru, vide reference 1st read above, the Government hereby permit P. Narayana Reddy College of Education, Pebbair Village, Post, Taluk & City, Mahbubnagar District-509104(now Wanaparthy District), Telangana State, to start B.Ed two years course, with an annual intake of 100 students, subject to the final orders of the Hon'ble High Court in W.P.No.10597/2018 and in Writ Appeals filed by the Government in W.A.No.9/2018 in W.P.No.32813/2017 and Writ Appeal No.1995/2017 in W.P.No.33310/2017 in similarly situated cases and the NCTE, SRC, Bangalore/New Delhi, dtd:07.04.2018 & 12.09.2018 (reference 4th& 8th read above).

11. The Director of School Education, Telangana, Hyderabad; the Secretary, Telangana State Council of Higher Education, Hyderabad; and the Registrar, Palamuru University, Mahbubnagar are requested to take further necessary action in the matter accordingly. Copy enclosed in the file."

AND WHEREAS, the SRC in its 366th meeting held on 03rd & 04th December, 2018 considered the matter and decided as under:

- 1. This is a B.Ed (2 units) case cleared by us.
- 2.1The Telengana Govt. had pointed out many deficiencies.
- 2.2The SCERT's name has wrongly come into this B.Ed. case. This will be a complaint from the Higher Education wing of the Telengana Govt.
- 3. The Telengana Govt. has now issued clearance for this B.Ed programme subject to the outcome in the court case concerned.
- 4. Let us issue a SCN to the Narayana Reddy College w.r.t. the inspection report sent by the Telengana Govt.
- 5. Keep the State Govt. and the affiliating university informed.
- 6. Put up in the February 2019 meeting.

AND WHEREAS, as per the decision of SRC, a show cause notice was issued to the institution on 18.12.2018. The institution vide letter dated 11.02.2019 submitted its reply to the show cause notice. The SRC in its 377^{th} meeting held on $03^{rd} - 04^{th}$ July, 2019 considered and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

(i) The Committee observed that the Management instead of furnishing the documents to substantiate the claim they are making a statement that the Govt. report are false. This is not expected from the Management interested to run Teacher Education Programme.

Taking into consideration the report sent by the Govt. of Telanagna, School Education (Training Department), the Committee decided to withdraw the recognition granted to P. Narayana Reddy College of Education, No. 420, 450, Plot No. 4,2nd Street, Pebbair Village, Post, Taluk & City, Mahbubnagar District-509104, Telangana for B.Ed. programme.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of P. Narayana Reddy College of Education, No. 420, 450, Plot No. 4,2nd Street, Pebbair Village, Post, Taluk & City, Mahbubnagar District-509104, Telangana run by Vishvabharathy Educational Society, No.9-26/1, Wanaparthy Road, Pebbair Village, Post, Taluk & City, Mahbubnagar District-509104, Telangana for conducting B.Ed programme of two years duration with an annual intake of 100 students (2 unit) on the grounds mentioned above.

Further, the institution offers and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course of training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training of after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
