RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely, NATIONAL EDUCATION COLLEGE, OM SHIV SHANKAR SHIKSHA EVAM SAMAJ KALYAN SAMITI, B-117, SAMADHIYA COLONY, KRISHNA VIHAR, GWALIOR- 474001, MADHYA PRADESH under section 14 of NCTE Act 1993 for conducting B.ED. (CO-ED).course vide order dated 13.05.2005 & 08.04.2010 for an annual intake of 100 students.

AND WHEREAS, one Shri Pawan Dubey had filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court had directed to inspect all B.Ed. institutions in the State of Violinga Pradesh. Since the institutions are existing institutions, the inspection was to be conducted by NCTE Hors, u's 13 of the NCTE Act.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 07.01.2015.

AND, WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 31.05.2015.

AND. WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...Follow up of Revised Orders for B.Ed. courses: The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item"

AND WHEREAS, the Show Cause Notice of compliance issued on 10.08.2016 and reply of compliance received on 15.10.2016.

AND WHEREAS, the matter was placed in 285th Meeting held on December 19-21, 2017 of WRC and the Committee decided that "... In response to the Show Cause Notice dated 10.08.2016, the institution has not submitted approved staff profile.

Building Completion Certificate not submitted.

FDRs of Rs. 12.00 lakhs (in joint name) not submitted in original.

Hence, Recognition is withdrawn. FDRs if any, be returned."

AND WHEREAS, the Withdrawal Order issued on 08.01.2018. The institution filed a appeal to the appellate authority Hqrs. no. APPL12141 dated 29.01.2018. Regulatory file sent to Hqrs. on 15.05.2018.

AND WHEREAS. Appeal order dated 05-06-2018. Decision Direction of the Appellate Authority
The committee concluded to be accounted to the WPC with a direction to consider the occurrent given in
appeal to be submitted to them by the appellant and take further action as per the NCTL Regulations, 2014. The
appellant is directed to forward to the WRC all the documents submitted in the appeal within 15 days of receipt
of the orders on the appeal. In the meanwhile, the order of withdrawal shall be kept in abeyance.

NOW THEREFORE, the Council hereby remands back the case of National Education College, Kedarpur, Piproli Road, Gwalior, M.P., to the WRC, NCTE, for necessary action as indicated above.
