Withdrawal Order U/S-17, 438, 437, 438

WHEREAS, recognition was granted to the institution, namely, NATIONAL EDUCATION COLLEGE, OM SHIV SHANKAR SHIKSHA EVAM SAMAJ KALYAN SAMITI, B-117, SAMADHIYA COLONY, KRISHNA VIHAR, GWALIOR 474001 MADHYA PRADESH vide order No. WRC/2-32/223153/72/2005/4167 dated 13.05.2005 for B.ED. (CO-ED) Course with an annual intake of 100 students.

AND WHEREAS, One Shri Pawan Dubey filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since the institutions are existing institutions, the inspection was conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 03.09.2014.

AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 07-01-2015

AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on **31.05.2015**.

AND, WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 June, 2016 and the Committee decided"... issue Show Cause Notice to the institution of the condition maintained in revised order."

AND, WHEREAS, a Show cause notice was issued to the institution on 10.08.2016 for not submitting compliance of Regulation 2014 required faculty staff list for two units and infrastructure the institution reply was submitted on dated. 15.10.2016.

AND WHEREAS, NCTE Hqrs. vide letter No.NCTE-Insp 011/246/2017-Insp Section HQ dated 15.09.2017 forwarded a first list of TEIs pertaining to WRC for issuing Show Cause Notice prior to withdrawal of recognition u/s 17 of the NCTE, 1993 for violating the request for filing necessary details as required by the NCTE Headquarters under powers vested as per Regulation 8(12) of Regulations, 2014.

AND WHEREAS, the aforesaid letter was placed before WRC in the 281st meeting held on September 19-20, 2017 and it was decided as follows:- "...In order to systematize the compilation of complete information of all TEPs in the country, the NCTE HQrs New Delhi had asked all institutions to submit the Mandatory Affidavit on the prescribed format. The first such Public Notice was issued on 05.10.2016. Further opportunity was given on 16.06.2017, and the last date for submission was 12.09.2017.

NCTE Delhi also issued Show Cause Notice through PUBLIC NOTICE to submit the Mandatory Affidavit within the specified date. Then, it compiled the list of institutions and identified TEIs which had not complied with the submission of Mandatory Affidavit. The lists were sent to the WRO to reconcile the discrepancies with regard toContinue next page

the address as well as duplication of entries for placing the list to WRC for initiating the process of derecognition of such institutions. These lists were tabled during the meeting.

The WRC perused the lists as provided by the Hqrs as well as the details provided by the WRO.

Thereafter, the WRC decided to issue Show Cause Notice u/s 17 of the NCTE Act for non-compliance of the directions of the NCTE, and why the institution should not be de-recognized"

Further directed by the chairperson WRC, the reply of such notices should be issued on or before 6^{th} November, 2017, for the 2^{nd} list received from NCTE Hqrs, after which further necessary action will be taken as per the Regulations.

AND WHEREAS, the Show Cause Notice was issued to the institution on **06.10.2017** and the reply of Show cause notice was received on **08.11.2017**.

AND WHEREAS, the matter was placed in 285th meeting of WRC held on December 19-21, 2017 and the Committee decided that "... In response to the Show Cause Notice dated 10.08.2016, the institution has not submitted approved staff profile.

Building Completion Certificate not submitted.

FDRs of Rs.12.00 lakhs (in joint name) not submitted in original.

Hence, Recognition is withdrawn from the academic session 2018-2019."

Now, therefore, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition granted to the institution for conducting B.Ed. course, is hereby withdrawn from the end of the academic session next following the date of order of Withdrawal.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 online against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
