ORDER

WHEREAS, WRC, NCTE had granted recognition/permission to **JAI HIND VISMIL EDUCATION COLLEGE, PORSHA CHOWRAHA DIVERSION ROAD, TEHSIL- AMBHA, MORENA- 476111, MADHYA PRADESH** vide order dated **26.09.2005** to start the **B.ED. (CO-ED)** course with an annual intake of **100** students.

AND WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on **17.01.2015**. The institution submitted affidavit vide letter dated **20.01.2015**.

AND WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on **28.05.2015**.

AND WHEREAS, the matter was placed in **255th Meeting of WRC held on June 22-24, 2016** and the Committee decided that "...issue Show Cause Notices to the institution of the condition maintained in revised order."

AND WHEREAS, the matter was placed in **259th Meeting of WRC held on September 21-23, 2016** and the Committee decided that "... Institutions which have requested for reducing intake may be permitted."

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

Now, therefore, the intake of the institution for conduct of B.Ed. course is hereby permitted to reduce the intake of 100 students (2 basic units) to 50 students (one unit).

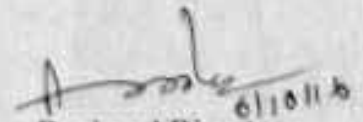
