WHEREAS, recognition was granted to the institution, namely, DEVI RUKMANI MAHAVIDYALAYA, PANCHSHEEL COLONY, BISTAN ROAD, KHARGONE-451001, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. course (100 Intake) vide order dated 07.06.2007.

- 2. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 01-01-2015.
- 3. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 28.05.2015.
- 4. AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."
- 5. AND, WHEREAS, a Show cause notice was issued to the institution on 17.08.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:
 - Staff Profile for the session 2015-16 duly approved by the affiliating body.
 - Originally notarized CLU/NEC/BP and Building Completion Certificate.
- 6. AND WHEREAS, the reply of show cause notice was submitted by the institution on 24.08.2016.
- 7. AND WHEREAS, the matter was placed in 306th Meeting of WRC held on April 29th-30th, 2019 and the Committee decided that "... The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

The revised recognition order was issued to the institution on 28/05/2015. The Show Cause Notice was issued to the institution 17/08/2016. The institution has submitted reply of Show Cause Notice on 24/08/2016.

On perusal of the reply of the institution, it is observed that the institution has not submitted following documents:

- · The institution has not submitted letter granting approval for the selection or appointment of faculty issued by the affiliating body as per NCTE Regulations 2014.
- The institution has not submitted original staff profile as per NCTE Amendment Regulations 2017.
- · The institution has not submitted land use certificate issued by the competent authority.
- The institution has not submitted NEC issued by the competent authority.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

- 8. AND, WHEREAS, the withdrawal order was issued to the institution on 09.05.2019.
- AND, WHEREAS, the institution submitted letter on 17.05.2019 with enclosed Court Order of Hon'ble High Court of Delhi at New Delhi, Date of Decision 16th May, 2019.

AND WHEREAS, the matter was placed in 307th Meeting held on May 30th-31st, 2019 of WRC and the Committee decided that "... Since WRC comes under the jurisdiction of Hon'ble M.P. High Court देवो रुक्मणी महाविद्यालय, खरगोन

and their benches, Counsel of the NCTE Hars be instructed to bring this to the kind notice of the Delhi High Court.

However, in view of the direction of the Hon'ble High Court of Delhi in W.P. No. (C) 5363/2019 and C.M. APPLs 23627/2019, 23628/2019 order dated 16/05/2019 at point No. 11, decision of WRC about the withdrawal order stands stayed and website be updated accordingly. However, other directions in the decision of the Hon'ble High court stand."

- 11. AND, WHEREAS, the information letter issued to the institution conveying decision of WRC in its 307th meeting on 04.06.2019. The institution filed an appeal NCTE, Hqr. on 22.05.2019. The Appellate Authority vide its order dated 16.07.2019 remanded back the case to the WRC, NCTE, for necessary action.
- 12. AND WHEREAS, the matter was placed in 312th Meeting held on January 27th -29th, 2020 of WRC and the Committee decided that "...The Committee considered the matter keeping in view the directions of the Hon'ble Court in Writ Petition No. 5362/2019 and also the Appellate Authority and recommends that the recognition of the institution be restored with an annual intake of two units."
- 13. NOW THEREFORE, the recognition of, DEVI RUKMANI MAHAVIDYALAYA, PANCH SHEEL COLONY, BISTAN ROAD, KHARGONE-451001, MADHYA PRADESH for conducting B.Ed. course with an annual intake of 100 students (two basic units of 50 students each).
