AND WHEREAS, the inspection of the said institution was conducted u/s 17 on 09.09.2010. The report of the visiting team was considered by WRC in its 142nd Meeting held from November 22-24, 2010 and it was decided that clarification be sought from the institution. Accordingly, letter issued on 13.12.2010.

AND WHEREAS, the reply submitted by the institution was considered by WRC in its 154th Meeting held from September 11-12, 2011, and it has been decided that as the institution has not submitted the reply to the clarification letter, the recognition for D.Ed. course be withdrawn under section 17(1) of the NCTE Act, 1993 from the end of the academic session next following the date of withdrawal order. Accordingly, withdrawal order issued on 07.01.2012.

AND WHEREAS, the institution preferred an appeal against the aforesaid order. The Council vide order dated 25.04.2012 accepted the appeal and remand the case for issuance of show-cause notice on the grounds mentioned in the WRC's clarification letter dated 13.12.2010 and also with reference to the complaint received against the institution.

AND WHEREAS, the aforesaid appeal order was placed in the 164th WRC meeting held from June 6-8, 2012 and the Committee decided that a show cause notice be issued to the institution so as to comply the instruction of the Appellate Authority. Accordingly, show cause notice issued to the institution on 12/07/2012 on the following points:-

- Institution is not in possession of land and building.
- Certified copy of land documents not submitted.
- Certified copy of CLU not submitted.
- Approved Building plan not submitted.
- Building completion certificate not submitted.
- Khasra, Khatoni and Aks not clear.
- Demarcated area for each course being run in the same premises not clear.

AND WHEREAS, the reply submitted by the institution was placed before WRC in its 171st meeting held from September 17-18, 2012, and the Committee decided to seek clarification from the institution. Accordingly, letter issued to the institution on 01/10/2012 on the following point:-

Certified copy by Sub-Registrar of land documents not submitted.
