Recognition Order

WHEREAS in terms of Section 14 (3) (a) of the NCTE Act, 1993, recognition was granted by WRC to YUVA VYAVSAIK SHIKSHAN MAHAVIDYALAYA ASHOK NAGAR M, GUNA ROAD, BERKHEDI, ASHOKNAGAR (M.P.) 473331 MADHYA PRADESH (Code No.- APW03639/223482) for conducting B.ED.course with an annual intake of 100 students vide order No. WRC/5-6/92/2006 dated 26.12.2006.

- 2. AND WHEREAS in its 115th meeting held on March ,21-23 ,2009 the Western Regional Committee after considering the report of the visiting team as well as other relevant material furnished by the applicant institution decided to withdrawal recognition on the said institution for B.ED course under section 17 (1) of NCTE Act, 1993 and accordingly the Refusal (Modified as withdrawal) Order No. WRC/APW03639/223482/2009/ R-4092-4097 dated 31/03/2009 was issued to the institution.
- 3 AND WAHEREAS the correspondent, YUVA VYAVSAIK SHIKSHAN MAHAVIDYALAYA ASHOK NAGAR M, GUNA ROAD, BERKHEDI, ASHOKNAGAR (M.P.) 473331 MADHYA PRADESH has preferred an appeal to NCTE New Delhi under section 18 of the NCTE Act, 1993 against the said Refusal (Modified as withdrawal) order dated 31/03/2009.
- 4. AND WHEREAS Council passed an order No **F.No.89-279/2009/Appeal** dated **13/08/2009** in the appeal filed by the institution and set aside the order of WRC **31/03/2009** with direction to WRC to restore recognition of the institution immediately.
- 5. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act. 1993, and as per the NCTE, New Delhi Order No F.No.89-279/2009/Appeal dated 13/08/2009 the Western Regional Committee hereby restore recognition granted to YUVA VYAVSAIK SHIKSHAN MAHAVIDYALAYA ASHOK NAGAR M, GUNA ROAD, BERKHEDI, ASHOKNAGAR (M.P.) 473331 MADHYA PRADESH vide order No. WRC/ No. WRC/5-6/92/2006 dated 26.12.2006 for conducting B.ED course of 1 year duration with an annual intake of 100 seats under clause 7 (11) of NCTE (Recognition Norms & Procedure) Regulation 2007.
