Withdrawal Order U/S-17

WHEREAS, recognition was granted to the institution, namely, YUVA VYAVSAIK SHIKSHAN MAHAVIDYALAYA ASHOK NAGAR M, GUNA ROAD, BERKHEDI, ASHOKNAGAR (M.P.) 473331 MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting **B.ED.** course vide order dated 26.12.2006 with an intake of 100 students.

- 2. AND WHEREAS, One Shri Pawan Dubey filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since the institutions are existing institutions, the inspection was conducted by NCTE Hqrs. u/s 13 of the NCTE Act.
- 3. AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 10.10.2015.
- 4. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 25-02-2015.
- 5. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 31.05.2015.
- 6. AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... The agenda by up by the RD was examined by the Committee. The Committee agrees with the proposal cossue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."
- 7. AND WHEREAS, a Show cause notice was issued to the institution on 19.09.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:
 - 1) Original Staff Profile (1-Principal+15-Faculties) for the session 2015-16 duly approved by the affiliating body,
 - 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.
- 8. AND WHEREAS, the reply of Show Cause Notice was not submitted by the institution & the matter was placed in 268th Meeting of WRC held on February 09th 11th, 2017 and the Committee decided that "... The list of 43 institutions was put up for considerations. In these cases, Show Cause Notice be issued to the institutions as to why the number of units in the B.Ed. course, which were given by revised order, should not be reduced/reversed."
- 9. AND, WHEREAS, the Show Cause Notice was issued to the institution on 15.02.2017 and the reply was received on 21.03.2017.
- 10. AND WHEREAS, the matter was placed in 310th Meeting of WRC held on August 19th-21st, 2019 and the Committee decided that "...The Show Cause Notice was issued to the institution vide letter dated 15/02/2017 and reply received on 21/03/2017.

The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice.

Moreover, the staff profile for approved intake is not submitted in original. Also staff at Sr. 3,5,6,10,12,14 & 15 are with less than 55% at P.G. Level. FDR not submitted in original. Building Completion Certificate, CLU & NEC are also not submitted.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

- 11. Hence, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition of the institution is hereby withdrawn from the end of the condemic session next following the date of order of Withdrawal.
- 12. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 **online** against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
