#### RESTORATION ORDER

WHEREAS, recognition was granted to the institution namely CHRIST COLLEGE RUN BY SOCIETY CHRIST ACADEMIC AND EDUCATION SOCIETY, BIAORA, BHOPAL ROAD, KACHNARIYA, BIAORA, RAJGARH-465674, MADHYA PRADESH, under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed course, with an annual intake of 100 students vide order no. WRC/5-6/100<sup>th</sup>/2008/32651 dated 07.04.2008.

- 2. AND WHEREAS, the Revised Recognition order was issued to CHRIST COLLEGE RUN BY SOCIETY CHRIST ACADEMIC AND EDUCATION SOCIETY, BIAORA, BHOPAL ROAD, KACHNARIYA, BIAORA, RAJGARH-465674, MADHYA PRADESH vide order no. F.No. /WRC/APW05501/223588/100/2015/137188 dt. 26.05.2015 for B.Ed. course of Two Years Duration with an annual intake of 100 students (Two Basic unit of 50 students each) from the academic session 2015-2016.
- 3. AND WHEREAS, the institution did not submit compliance as per NCTE Regulations 2014.
- 4. **AND WHEREAS,** the matter was placed in **255**<sup>th</sup> Meeting of WRC held on **June 22-24, 2016** and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item in the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."
- 5. **AND WHEREAS,** a Show Cause Notice was issued to the institution on 21.10.2016 for not submitting the documents in compliance of NCTE Regulation 2014 mentioned in the revised order.
- 6. **AND WHEREAS,** the reply of show cause notice was submitted by the institution on dt. 14.12.2016.
- 7. **AND WHEREAS,** the matter was placed in 285<sup>th</sup> meeting held on December 19<sup>th</sup> to 21<sup>st</sup>, 2017 of WRC and the Committee decided to seek clarification from the institution.
- 8. **AND WHEREAS,** a clarification letter was issued to the institution on 03.01.2018 as per decision of WRC, and its reply received on dt. 13.02.2018 and 28.02.2018.
- 9. **AND WHEREAS,** the matter was placed in 310<sup>th</sup> Meeting held on August 19<sup>th</sup> to 21st, 2019 of WRC and the Committee decided that.

The clarification letter was issued to the institution vide letter dated 03/01/2018 and reply received on 13/02/2018.

The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice.
