The institution shall adhere to the fulfillment of the provisions of the NCTE Regulations, 2014, as amended from time to time, and ensure the following before commencement of the session: -

- (i) The institution shall comply with various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
- The institution shall make admissions only after it obtains affiliation from the examining body in terms of Clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- (iii) The institution shall comply with condition laid down in clause 8(3) of the NCTE Regulations, 2014, as amended vide Notification on 29.04.2017 which provides as under:-
  - An institution, which has been recognised by the Council shall obtain accreditation from an accrediting agency indentified by the Council within five years of the date of recognition.
  - All existing Teacher Education Institutions which have not been accredited so far or have not been accredited within five years from the date of its recognition shall be required to get themselves accredited by the aforsiad accrediting agency within a period of one year from the date of notification of these Regualtions.
  - The accreditation once obtained shall be valid for a period of five years and the recognised and already accredited Teacher Education Institutions shall be required to get accreditation renewed by the agency identified for the purpose by the Council before the lapse of the earlier accreditation.
- (iv) The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- (v) The Norms for teaching staff in respect of their qualifications and experience shall be as per provisions of NCTE Regulations. 2014, as amended from time to time.
