RESTORATION ORDER

WHEREAS, the recognition was granted to the institution, namely, S.S. COLLEGE OF EDUCATION, 3K 47, VINAYAK MARG, SECTOR No.5, HIRAN MAGRI, UDAIPUR PIN - 313001, RAJASTHAN for B.ED. with an intake 100 students course of one year duration with an annual intake of 100 students vide Order F.NRC/NCTE/RJ-1043/2007/24610-16 dated-06.08. 2007

- AND WHEREAS after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide Order No. F.No.NRC/NCTE/RJ-Common Orders/2015/116329-398 dated. 11.06.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.
- AND WHEREAS, the matter was considered by WRC in its 387th meeting held on 09 & 10th June, 2023 and the Committee decided that the recognition of B.Ed. programme of institution be withdrawn under clause 17(1) of the NCTE Act, 1993, with effect from the end of the academic session next following the date of communication of the said order. Accordingly, Withdrawn Order was issued dated 13.07.2023.
- AND WHEREAS, institution filed an appeal under Section 18(1) NCTE Act, 1993 before the Appellate Authority at NCTE, New Delhi against the aforesaid withdrawal order.
- AND WHEREAS, in light of order dated 08/04/2021 passed in the W.P. (c) No. 4382/2021 and dated 30.07.2021 passed in W.P. (c) No. 7260/2021 by the Hon'ble High Court of Delhi and submission made by the Institution before the Appeal Committee the withdrawal Order dated 13.07.2023 passed by WRC was set-aside by the Appellate Authority vide its order dated 12.09.2023 and remand back to WRC.
- AND WHEREAS, WRC in its 385th meeting held on 17th may, 2023 has taken the following decision, "the committee unanimously resolved that all such matters where the case is remanded back by the appellate authority or through the orders of the court, the Regional Director is authorized to issue restoration order pending re-consideration of the withdrawal order.
