WHEREAS, in terms of section 15(3)(a) of the NCTE Act 1993, WRC granted recognition to P.B.G.M. COLLEGE, RUN BY NIVEDITA EDUCATIONAL RESEARCH TRAINING & DEVELOPMENT COUNCIL, JAIN MANDIR ROAD, JEHANGIRABAD BHOPAL 462008, MADHYA PRADESH for D.EL.Ed. course vide order dated 05.01.2007 for an annual intake of 50 students.

AND WHEREAS, the institution applied under clause 8(11) of NCTE Regulations 2009, for change of premises of D.EL.ED. course from P.B.G.M. COLLEGE, RUN BY NIVEDITA EDUCATIONAL RESEARCH TRAINING & DEVELOPMENT COUNCIL, JAIN MANDIR ROAD, JEHANGIRABAD BHOPAL 462008, MADHYA PRADESH **to** P.B.G.M. COLLEGE, PLOT NO.-153/2, 166/1, TEHSIL- HUZUR, CITY- BHOPAL, PINCODE- 462038, DISTRICT- BHOPAL, MADHYA PRADESH.

AND WHEREAS, the visiting team constituted by the WRC inspected the new premises on 23 & 24.09,2013.

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before the WRC in its  $236^{th}$  Meeting held on December 15-16, 2015. The Committee decided as under:-

...When this file was seen in the 192<sup>nd</sup> meeting (October 30-31, 2013), it was noticed that the Management has not been able to submit a building completion certificate from Bhopal Municipal Corporation, in which jurisdiction the building is located. In the 228th meeting (June 15-16, 2015), it was informed that the Bhopal Municipal Corporation has refused to give building completion certificate on the ground that only part of the building is completed. Hence, Show Cause Notice dated 23.06.2015 was issued. The applicant has now submitted a building completion certificate from a private architect. His claim in his letter dated 22.07.2015 is that the Bhopal Municipal Corporation has stated that the constructed area is 3698.63 sq.mts. which is more than the area required for two courses. Though an actual certificate from Bhopal Municipal Corporation has not been submitted, the letter from the Municipal Corporation states that 3698.63 sq.mts. have been constructed. This is borne out by the certificate from the Private Architect. Since, the requirement of built up area for teacher education course is available, shifting is permitted."

NOW THEREFORE, in exercise of the powers vested under section 15(3)(a) of NCTE Act, 1993, permission under clause 8(9) of NCTE Regulation, 2014, is hereby granted for change of premises from P.B.G.M. COLLEGE, RUN BY NIVEDITA EDUCATIONAL RESEARCH TRAINING & DEVELOPMENT COUNCIL, JAIN MANDIR ROAD, JEHANGIRABAD BHOPAL 462008, MADHYA PRADESH to P.B.G.M. COLLEGE, PLOT NO.- 153/2, 166/1, TEHSIL- HUZUR, CITY- BHOPAL, PINCODE- 462038, DISTRICT- BHOPAL, MADHYA PRADESH, with immediate effect for conducting D.EL.Ed. course of two years duration with an annual intake of 50 students. The institution has to be a composite institution gradually preferably by 2016-2017.

The institutions shall maintain the teaching staff strength of 1+5 for the sanctioned D.Ed. course and all the appointments would be on regular basis on an approved scale of payment of the candidates having fulfilled eligibility condition prescribed by NCTE. The institute concerned shall send a report in this regard to WRC of NCTE within 30 days, in terms of clause 7 (12) of the NCTE Regulations 2005.

The institutions shall note that with regard to NET / SLET requirement, the relaxation is (b) allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.7.2006.

The institutions shall adhere to all the other regulations and guidelines as framed by NCTE (c)

from time to time.

The institutions shall within one month of the receipt of the Recognition order, convert the (d) Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an authorized official of the Regional Committee.

That the Reserve fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in (e)

favour of the managements / institutions.

Further, the recognition is subject to fulfillment of all such other requirements as may be (f)

prescribed by other regulatory bodies like UGC and State Government etc.

The institutions shall submit to the Regional Committee a Self Appraisal Report at the end of (g) each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

The institutions shall regularly update their website. (h)

- The institutions intending to run the teachers training programme approved above in a rented (i) premises are required to submit report in compliance of the requirement of NCTE Regulations on the subject regarding their shift to permanent building.
- If any of the institutions contravene any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and / or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act 1993. The NCTE Hqrs. May also cause inspections under Section 13 of NCTE Act, 1993.
