RECOGNITION ORDER

WHEREAS, recognition was granted to the institution namely, **SHRI SAI MAHAVIDHYALAYA, PLOT NO.- 3/1, 5/4, VILL-NIIWARI BHATA, P.O.-NIWARI, TEH-NIWARI, TIKAMGARH-472442, MADHYA PRADESH** under section 14(1) of the NCTE Act, 1993 for conducting **B.ED.** course of annual intake of 50 (One basic Units of 50 students) vide order No.APP3156/223/251st /2016 dated 02.05.2016.

AND WHEREAS, the matter was placed in 316th Meeting held on 27th to 28th August & 04 September 2020 and the Committee decided that..."The committee considered the matter in view of the order of appellate authority, agenda note and decided to constitute a committee consisting of following to examine the documents and submit its report for perusal and further consideration by WRC. "

The committee so formed has submitted its report vide e-mail dated 26.01.2021. The committee has observed as follows:

"From the above facts I understand that the affidavits are in a sense requests for permitting an intake of 100 students. It needs, "...seeking grant of recognition/permission for conducting a course in Teacher Education titled B.Ed. with an intake of 100." The first affidavit shows some tinkering but the later one (of 28.04.2016) clearly mentions 100. In spirit the affidavits are pleas. It is logical to believe that there is no malafide intention in these because they fulfill all other requirements for conducting two units.

Therefore, I believe that Shri Sai Mahavidyalaya may be permitted to have an intake of 100 students if the committee agrees to this."

AND WHEREAS, the matter was considered by WRC in its **329th Meeting held on 17-19 February 2021** and WRC decided (Ref: Sl. No. 96, Page No.65-66 of 329th WRC Minutes) as under: -

2. The institution filed an W.P. before Hon'ble High Court, New Delhi and Hon'be Court vide order dated 18.12.2020 has directed to WRC to consider the representation of the petitioner for remaining one basic unit (50 seats) within eight weeks.
3. The Committee considered the Hon'ble Court order as well as documents submitted by the institution and found fit the case for issuance Revised Recognition order for remaining one unit of 50 seats.

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, **LATE SHRIMATI LADKUNWAR SMRITI SIKSHA AVAM KALYAN SAMITI, PLOT NO- 115, STREET- KHARE MUHALLA, VILLAGE- NIWARI, POST OFFICE- NIWARI, TEHSIL- NIWARI, DISTRICT: TIKAMGARH- 472442, MADHYA PRADESH (WRCAPP3156/223)** had submitted on **29-06-2015** the application to the Western Regional Committee of the NCTE for grant of recognition to **SRI SAI MAHAVIDHYALAYA RUN BY LATE SHRIMATI LADKUNWAR SMRITI SIKSHA AVAM KALYAN SAMITI, PLOT NO- 3/1, 5/4, VILLAGE- NIWARI BHATA, POST OFFICE- NIWARI, TEHSIL- NIWARI, DISTRICT: TIKAMGARH- 472442, MADHYA PRADESH** for **B.ED. AND WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 1.12.2014.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its **251st** meeting held on 30 April – 02 May, 2016 is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed. programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition to **SRI SAI MAHAVIDHYALAYA RUN BY LATE SHRIMATI LADKUNWAR SMRITI SIKSHA AVAM KALYAN SAMITI, PLOT NO- 3/1, 5/4, VILLAGE- NIWARI BHATA, POST OFFICE- NIWARI, TEHSIL- NIWARI, DISTRICT: TIKAMGARH- 472442, MADHYA PRADESH** for conducting **B.ED. programme of 2 (Two) years duration with an annual intake of 50 students (one basic unit of 50 students)** from the academic session **2016-17**.

The institution shall gradually move towards becoming a composite institution as per clause 8(1) of the NCTE Regulations, 2014.

The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the examining body in term of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The institution shall ensure that the required number of academic staff for conducting the course is always in position.

The recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.

The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display the following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution contravenes the provision of the NCTE Act, Rules, Regulations and Orders made and issued thereunder, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

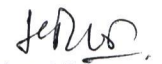
