### WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely, R.D. MEMORIAL COLLEGE OF PHYSICAL EDUCATION, KHASRA NO.118, 119, 120/1, 102/2, 134/1/1, 134/2/4, VILLAGE: BARKHEDI KALAN, BHADBHADA ROAD, BHOPAL, MADHYA PRADESH for conducting B.P.Ed. course of two years duration with an annual intake of 50 students vide order dated 27.09.2006.

AND WHEREAS, in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) issued the revised recognition order dated 20.05.2015 for conducting B.P.Ed. programme of two years duration with an annual intake of 100 students (one basic unit with two section of 50 (fifty) each) from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

AND WHEREAS, Barkatullah University conducted inspections in B.P.Ed. colleges on the basis of complaints received against the institutions. The University vide letter dated 19.12.2016 has forwarded these inspection reports to WRC, NCTE, Bhopal.

AND WHEREAS, the matter was considered by WRC in its 271st meeting held on March 23-25, 2017 and it was decided that "...The inspection report received from the Barkatuilah University, Bhopal was perused. The inspection report reveals the following:-

The institution has not earmarked the built up area for each of the courses run by it.

(i) (ii) The teaching staff is not as per NCTE norms and only two were approved by the University.

The institution should comply the above and submit details regarding courses being run and area allocated, list of laboratories and the equipment as also the list of staff approved by the affiliating body. Hence, Show Cause Notice be issued as to why the recognition should not be withdrawn on the above grounds. Reply should be submitted within 30 days." Accordingly, Show Cause Notice was issued on 21.04.2017.

AND WHEREAS, the reply not submitted by the institution and the matter was placed before WRC in its 277th meeting held on June 29-30, 2017 and the Committee decided that "... Show Cause Notice was issued to the institution on 21/04/2017. The institution has not replied to the Show Cause Notice till date. Hence, Recognition is withdrawn. FDRs, if any, be returned."

NOW THEREFORE, the recognition granted to R.D. MEMORIAL COLLEGE OF PHYSICAL EDUCATION, KHASRA NO.118, 119, 120/1, 102/2, 134/1/1, 134/2/4, VILLAGE: BARKHEDI KALAN, BHADBHADA ROAD, BHOPAL, MADHYA PRADESH for conducting B.P.Ed. course vide order dated 27.09.2006 is hereby withdrawn under section 17(1) of the NCTE Act, 1993.

#### Revised Order

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the R.D. MEMORIAL COLLEGE OF PHYSICAL EDUCATION, KHASRA NO. 118, 119, 120/1, 102/2, 134/1/1, 134/2/4, VILLAGE: BARKHEDI KALAN, BHADBHADA ROAD, BHOPAL, MADHYA PRADESH by affidavit dt. 28.02.2015 has consented to come under new Regulations and sought for a basic unit of 100 (one hundred) students with two sections of 50 (fifty) each in B.P.Ed. Course, which require additional
- AND WHEREAS, it has been decided to permit the institution to have a basic unit of 100 (one hundred) students with two sections of 50 (fifty) each in B.P.Ed. Course, subject to the institution fulfilling following conditions namely,
  - The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
  - II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
  - III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
  - IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.
  - NOW THEREFORE, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to R.D. MEMORIAL COLLEGE OF PHYSICAL EDUCATION, KHASRA NO. 118, 119, 120/1, 102/2, 134/1/1, 134/2/4, VILLAGE: BARKHEDI KALAN, BHADBHADA ROAD, BHOPAL, MADHYA PRADESH for conducting B.P.Ed. programme of two years duration with an annual intake of 100 students (one basic unit with two sections of 50 (fifty) each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.
  - Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
  - The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
