Order

WHEREAS, recognition was granted to SUNDER LALA SHRIVASTAVA MEMORIAL B.ED. COLLEGE, NEAR GRAM PANCHAYAT BHAWAN, RAJA KHARI, SAGAR 470004, MADHYA PRADESH for conducting B.ED. course vide order No. WRC/2-32/223245/76/2005/6218 dated 09/08/2005 for an annual intake of 100 seats.

AND WHEREAS, the Hon'ble High Court of Judicature at Jabalpur, vide common order dated 31.07.2008 passed WP No. 6113/2008 and WP No. 8936/2008 directed the Apex body of the NCTE to find out whether the said recognitions were valid as per the NCTE Act and the Regulations framed there under.

AND WHEREAS, in compliance of the Hon'ble High Court direction the inspection of the institution was conducted by the NCTE under section 13 of the NCTE Act, 1993.

AND WHEREAS, in compliance of the Hon'ble High Court directions, the NCTE submitted its report before the Hon'ble High Court that the institution did not fulfill the prescribed norms and standards on which the Hon'ble High Court vide its common order dated 19.02.2009 passed in WP No. 6146/2008 and other 3 other matter directed the NCTE to communicate the decision of refusal of recognition with liberty to the institution to prefer written representation as per the provision of the NCTE Act, 1993.

AND WHEREAS, the Western Regional Committee in its 142nd meeting decided to withdraw the recognition of the said institution for B.Ed. course and accordingly the withdrawal order No. WRC/APW01731/223307/142ND/2010/72450-72456 dt. 14/12/2010 was issued to the institution.

AND WHEREAS, the institution approached Hon'ble High Court through W.P. No. 9500 of 2009 and court order dated 19/04/2012 passed by the Hon'ble Madhya Pradesh High Court of Judicature at Gwalior.

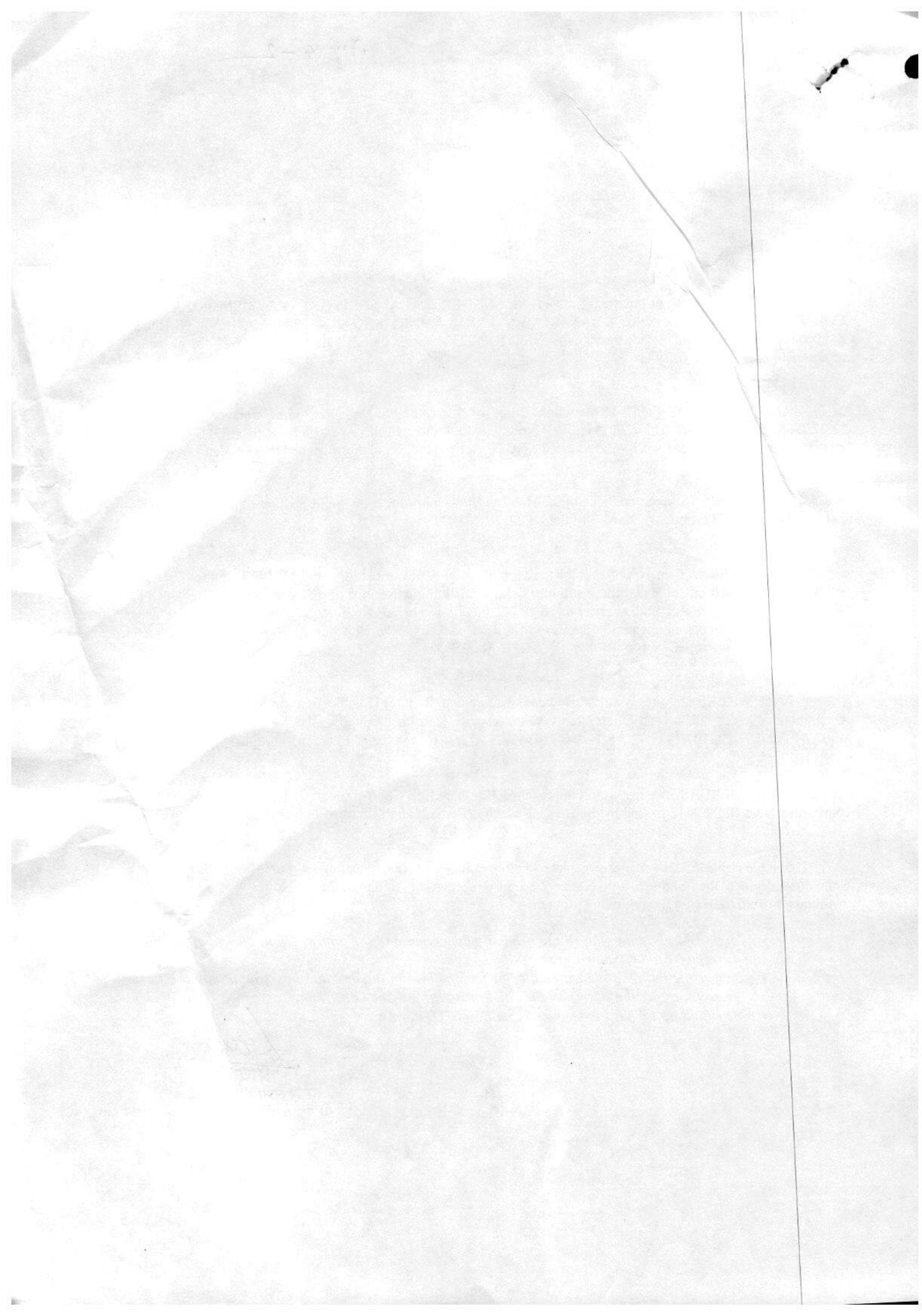
AND WHEREAS, the matter was placed before WRC in its 162nd meeting held on May 10, 2012 and the Committee decided that Show Cause Notice be issued. Accordingly, Show Cause Notice was issued to the institution on 16/07/2012 on the following grounds:-

- *Approved building plan in the original application and the approved building plan submitted as response to the Show Cause Notice.*
- *As per the building plan submitted by the application the building has ground and two floors whereas, as per the VT report the building has ground and one floor.*
- *The built up area is inadequate as per the NCTE norms.*

AND WHEREAS, the reply dated 30/07/2012 submitted by the institution was placed before WRC in its 173rd meeting held on November 5, 2012 and the Committee observed that Show Cause Notice dt. 16.7.2012 was issued to the petitioner as per Court order to which his reply has been received along with the documents. The documents have been examined and found to be in order. Hence, WRC decided that recognition be restored.

NOW THEREFORE, the Western Regional Committee hereby restores the recognition granted to SUNDER LALA SHRIVASTAVA MEMORIAL B.ED. COLLEGE, NEAR GRAM PANCHAYAT BHAWAN, RAJA KHARI, SAGAR 470004, MADHYA PRADESH for conducting B.ED course with an annual intake of 100 seats with the same terms and conditions as mentioned in the recognition order dated 09/08/2005.

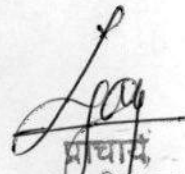

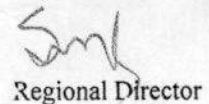
