AND WHEREAS, the institution, JAIN COLLEGE, RUN BY MANODEEP HIGHER EDUCATION SOCIETY, KHASRA NO.133 M 1,2, 134 M 1,2, 109, 135, PLOT NO.133, STREET NO./VILLAGE - SALUPURA, POST OFFICE -ITM POST OFFICE, TEHSIL/TALUKA/TOWN/CITY/DISTRICT - GWALIOR, PIN CODE - 474001, MADHYA PRADESH (WRCAPP3236) has by affidavit consented to come under New Regulations.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its 245th meeting held on March 1-3, 2016 was satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the D.El.Ed. programme, such as infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
