
- 2. AND WHEREAS the inspection of the institution was conducted on 02/11/08 by a visiting team.
- 3. AND WHEREAS in its 112th meeting held on 7-8 December, 2008 the Western Regional Committee after considering the report of the visiting team, perusal of videography as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 25/12/2008 to the applicant institution under proviso to Section 14/15 (3) (b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 4. AND WHEREAS the applicant institution had submitted representation dated 14/01/09 to WRC, NCTE. The said representation of the institution was duly considered by the Western Regional Committee in its 114th Meeting held on 4-5 February, 2009, which came to the conclusion that recognition/permission to the said institution be refused for the following reasons.
- 1. One building plan is the name of the society and the area is only 790 sq.mts. which is inadequate as per NCTE norms.
