And whereas, the institution has made representations vide letter dt. 18.02.2022, 09.04.2022 & 23.07.2022 requesting WRC for the issue of the order for Shifting D.El.Ed. course.

And whereas, the matter was placed in the 370^{th} meeting of WRC held on 10^{th} to 12^{th} September 2022, and the committee has decided the following:

"...The original file of the Institution along-with other related documents, representations from institution dated 03.02.2022, 18.02.2022, and 26.03.2022 related to mentioning of D.El.Ed. course in the shifting permission order already issued by WRC-NCTE dated 22.02.2016 were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTF from time to time and the Committee observed as under:

- The inspection conducted for shifting of premises for both B.Ed. and D.El.Ed. courses on 24.09.2015 and VT report received on 07.10.2015.
- NRC in its 249th meeting held on 01st to 10th February, 2016 (Part-5, 06-09 February, 2016) has decided that the institution is allowed to shift both B.Ed. and S.T.C. course at the new address.
- Inspection of institution for shifting conducted while both B.Ed. and D.El.Ed. courses were recognized.
- Order for shifting of premises dated 22.02.2016 was issued by NRC mentioning that only B.Ed. course is recognized.
