Course of 2 Year with an annual intake of 50 (Fifty) seats from the academic session 2014-2015, in the light of Hon'ble Supreme Court Order dt. 13-12-2012, in WP (Civil) 276/2012.
- Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations, 2009.

- The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.
