- 10. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always following as mandatory disclosure:
 - Copy of the Application Form (i)
 - Land and Building Particulars. (iii)
 - Staff Profile. (iii)
 - Recognition letter. (iv)
 - Information for having fulfilled the norms & standard and other required conditions. (v)
- 11. If the institution contravenes any of the above conditions or the provisions of the NCTI: Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
- 12. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, I, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
