RESTORATION ORDER 325,326,327,330, 378, 379

WHEREAS, the recognition was granted to the institution namely INDIA INTERNATIONAL COLLEGE OF EDUCATION, RUN BY SHREE KHERAPATI MAHARAJ SHIKSHA SAMITI, PLOT NO.606, VILLAGE - DABRA, GWALIOR, MADHYA PRADESH for D.Ed. Course vide order dated 29.07.2008 for an annual intake of 50 seats.

AND WHEREAS, the complaint received from Madhyamik Shiksha Mandal, Bhopal against the Colleges located in Gwalior was considered by the WRC in its 229th meeting held on July 21-22, 2015 and it was decided that "the complaint be put up with recognition status of 39 institutions mentioned in the letter for consideration."

AND WHEREAS, the matter was again considered by the WRC in its 231st meeting held on August 25-26, 2015 and it was decided that "...the institutions figuring in the list provided by the Madhyamik Shiksha Mandal be verified from the records whether the inspection of the institutions was carried out by the Collector, Gwalior earlier and after verification, detailed note be submitted for consideration."

AND WHEREAS, the Collector, Gwalior vide letters dated 23/11/2015 and 16/12/2016 forwarded the reports of inspection to the office of Lokaayukt, M.P. which were forwarded to Madhyamik Shiksha Mandal vide their letter dt. 15/03/2016. Madhyamik Shiksha Mandal forwarded the copy of reports to the WRC for action against the institutions.

AND WHEREAS, the matter was placed before WRC in its 253rd meeting held on May 24-26, 2016 and the Committee decided as follows "As per report the staff was not found available at the time of inspection. Hence, Show Cause Notice under section 17 be issued to the institution on the ground that no activity was being conducted at the time of inspection. Neither students nor staff was available. Building was not found at the time of inspection. Further, the institution should submit the latest approved list of the staff." Accordingly, Show Cause Notice issued to the institution on 15.06.2016. Reply not submitted by the institution.

AND WHEREAS, the matter was placed before WRC in its 259th meeting held on September 21-23, 2016 and the Committee decided that "...Show Cause Notice was issued to the institution on 15/06/2016. Till date no reply has been received. Hence, Recognition is withdrawn under Section 17 of the NCTE Act, from the end of the academic session next following the date of withdrawal. No new admissions will be permitted from the session 2017-2018." Accordingly, Withdrawal order was issued on 27.09.2016.

AND WHEREAS, the institution preferred an appeal before the Council (NCTE) u/s 18 of NCTE Act, 1993, against the Withdrawal order dated 27.09.2016 and the Council vide order dated 18.04.2017 remanded the case to WRC with a direction for considering the reply dated 27.07.2016 submitted by appellant in response to SCN dated 15.06.2016.

AND WHEREAS, the reply received from the institution and aforesaid appeal order was placed in the 277th Meeting of WRC held on June 29-30, 2017 and the Committee decided that, "...This is a case of Appeal. As directed by the Appellate Authority, the institution has submitted a photocopy of list of faculty. The institution is required to submit the list of faculty approved by the affiliating authority in original. The signature of approval should be on each page. The institution is also required to send the salary statement duly attested by the Bank for the past 3 months. Show Cause Notice be issued on the above grounds. Reply be submitted within 1 month." Accordingly, Show Cause Notice was issued on 06.07.2017.

AND WHEREAS, the reply received from the institution was placed in the 278th Meeting of WRC held on July 25-26, 2017 and the Committee decided that "...The case file was seen. In response to show cause notice letter dt. 06.07.2017, the institute has submitted a list of one Principal and 7 faculty members approved by the competent authority. However, the institute has submitted a salary statement from the institute which has been shown as been received in the bank. What is required is a statement from the bank that salary of each staff has been credited to their respective accounts. Hence, clarification be issued to the institution. Reply should be received within 1 month." Accordingly, Clarification letter was issued on 31.07.2017

AND WHEREAS, the reply received from the institution was placed in the 282nd Meeting of WRC held on October 24-26, 2017 and the Committee decided that "...The institution was required to submit statement from the bank regarding crediting of salaries. The institution has submitted the required documents. **Hence, Recognition is restored."**

NOW, THEREFORE, the Western Regional Committee hereby restores the recognition to INDIA INTERNATIONAL COLLEGE OF EDUCATION, RUN BY SHREE KHERAPATI MAHARAJ SHIKSHA SAMITI, PLOT NO.606, VILLAGE – DABRA, GWALIOR, MADHYA PRADESH for conducting D.Ed. Course with an annual intake of 50 seats with the same terms and conditions as mentioned in the recognition order dated 29.07.2008.
