WRC, NCTE vide order No.WRC/2-32/222071/77(CON)/2005/7655 dated 26.09.2005 granted recognition to MALHOTRA COLLEGE, PLOT NO. 232/2, VILL.- BADWAI, P.O.- KAROND M.L. NAGAR, TEH.- HUZUR, DIST.- BHOPAL-462038, MADHYA PRADESH (Code No. APW01869/222071) for D.ED. Course for an annual intake of 50 students for the academic session 2005-2006.

WHEREAS, WRC, NCTE vide order No.WRC/5-6/222071/90/2006/4174-4180 dated 20.11.2006 granted formal recognition to the institution for D.ED. Course for an annual intake of 100 students from the academic session 2005-2006.

WHEREAS, the institution filed Writ Petition No. 15154/2011 in the Hon'ble High Court of Madhya Pradesh, Seat at Jabalpur and the court had passed an order dated 22.02.2012.

WHEREAS, the court order dated 22.02.2012 was placed in the 161st WRC meeting and it was decided as follows:-

"The case file was seen. In this case the WRC had decided to grant recognition to the institution for an intake of 50 students for D.Ed. in its 77th meeting. However, when the formal recognition order was issued, it mentions intake of 100 students instead of 50 at one point in the letter. When the WRO verified the list and informed the Board Office about 50 seats in this institution, the institution approached the High court. The High Court in their order dt. 22.2.2012 has directed respondents no. 1 and 2 to clarify the position by a clarificatory order. Hence it is required that order No.WRC/5-6/222071/90/C-4174-4180 dt. 20.11.2006 signed by Mr. B. Krishna Reddy be revised to state that the intake permitted to this college is for 50 students only. In this clarificatory letter, it should be pointed out that the 26.9.2005 letter also mentioned only 50 intake. In the letter 20.11.2006 also, only intake of 50 is mentioned. Unit of 1+5 staff is also for 50 students only."

WRC during the course of meeting have decided that order No.WRC/5-6/222071/90/C-4174-4180 dated 20.11.2006 signed by Mr. B. Krishna Reddy be revised to state that the intake permitted to this college is for 50 students only as the recognition granted to the institution issued vide letter No.8888 dated 26.09.2005 mentions the intake of 50 as per decision of 77th meeting of WRC. Also in formal recognition order issued vide order No. WRC/5-6/222071/90/C-4174-4180 dated 20.11.2006, in para 3 mentions intake of 50 and in subsequent para 3(b) it states that unit of 1+5 staff is also for 50 students only. Hence, in para where 100 intake is mentioned is a typographical error.

NOW THEREFORE, it is hereby clarified that the intake mentioned in the para 3 of the order dated 20.11.2006 be read as 50 students instead of 100 students.

The other matters contents of the recognition order dated 20.11.2006 will remain unchanged.
