Order for Shifting of Premises

WHEREAS, the institution, namely SUNRISE INSTITUTE OF EDUCATION, SURVEY NO-73/4, VILLAGE-DABKA, TALUKA/MANDAL-GWALIOR, TOWN/CITY-DABKA, DISTRICT-GWALIOR, MADHYA PRADESH, PIN CODE-474001 was granted recognition by WRC NCTE for B.Ed. Course of two years duration with an annual intake of 50 students (one basic unit of 50 students) from the academic session 2017-2018 vide order No.WRC/APP201660026/ID No.7763/275th/2017/185670-185677 dated 05.05.2017 and for D.El.Ed. Course of two years duration with an annual intake of 100 students (two basic units of 50 each) from the academic session 2017-2018 vide order No.WRC/NCTE/ APP3505 / 222 / 275th/D.El.Ed./{M.P.}/2017/185356-185363 dated 05.05.2017.

- AND WHEREAS, the institution had submitted an application dated 12.02.2020 requesting to shift its premises from existing location, Survey no-73/4, Village-Dabka, town/city-Dabka, District-Gwalior, Madhya Pradesh to new location Survey no-1302/1, 1303/1, 1305/1, 1306/1, 1312/1, 1302/2, 1303/2, 1305/2, 1306/2, 1312/2, Village-Kaitha Talpura, Tehsil-Gwalior, District-Gwalior, Madhya Pradesh.
- AND WHEREAS, being aggrieved with its pending shifting application, the institution had filed case before the Hon'ble High Court of Delhi at New Delhi in W.P.(C) 6999/2022 and Hon'ble Court passed order dated 05.05.2022, the operative part is as under:
- "... 3. In the light of this stand taken by the respondent, even though no counter affidavit is called for, the writ petition is disposed of by directing the respondent no.2 to decide the petitioner's application within a period three months by following the due process including conducting of inspection of the new premises where the petitioner proposes to shift its institute. However, on account of the delay on the part of the petitioner in approaching the Court, the writ petition is being allowed subject to the payment of costs of Rs. 10, 000/- by the petitioner. The costs be paid to "Indigent & Disabled Lawyers' Fund" of Bar Council of Delhi [A/C No.010104000183451].
- AND WHEREAS, the matter was placed in 368th meeting of WRC held on 27th & 28th July, 2023 4. and Committee decided that V.T. to be constituted and therefore the inspection of the institution to consider the case for Shifting of Premises was conducted on 22.12.2022.
- 5. AND WHEREAS, visiting team was constituted online on 22.12.2022 and online Visiting Team Report was considered by WRC in its 379th meeting held on 17th January, 2023 and the committee decided that Show Cause Notice issue to the institution. Accordingly, Show Cause Notice issued to the institution on 28.02.2023.

"The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

The reply of show cause notice submitted by the institution was considered by the WRC and WRC decided that the permission for Shifting of premises be granted to the institution for shifting of premises for its B.Ed. and D.El.Ed. Course in its new premises i.e. Survey No. 1302/1, 1303/1, 1305/1, 1306/1, 1312/1, 1302/2, 1303/2, 1305/2, 13062, 1312/2, Village – Kaitha, -Talpura, Tehsil-Gwalior, Distt. Gwalior, M.P."
