The recognition was granted to the institution namely ORIENTAL B.ED. COLLEGE, KHASRA NO. 254/4-5-6-7, 257/3-4-5-6, 254/2, 256/1-2, 257/1, 121/2, VILLAGE: PANBIHARI, STREET/ROAD: NEAR BLOCK OFFICE, TALUKA/MANDAL: LALBURRA, TOWN/CITY: PANBIHARI, DISTRICT: BALAGHAT-481441, MADHYA PRADESH vide Order no. WRC/APP201660058/7881/B.A.B.Ed./M.P./286th/2018/194392 dated 23.01.2018 for B.A.B.Ed. integrated course of 4 years duration with an annual intake of two basic unit(s) of 100 students.

The matter was considered by WRC in its 296th meeting held on August 28-29, 2018 and Committee decided as under:-

"The NCTE hqrs. vide letter No.68759 dated 02.08.2018 has directed the WRC to reconsider the cases where recognition was granted to institutions which had staff members who were not qualified with for want of Ph.D./NET w.r.t. NCTE notification published on 09.06.2017.

A re-examination of the following files shows that some Assistant Professor(s) do not have Ph.D. or NET.

- (ii) UMA VINDYAVASNI SANSKAR MAHAVIDHYALAYA, SURAJPUR, CHHATTISGARH (APP7277)
- (iii) SAINATH INSTITUTION, KATNI, MADHYA PRADESH (APP201660107)
- (iv) ORIENTAL B.ED. COLLEGE, LALBURRA, MADHYA PRADESH (APP201660058/7881)
- (v) SCHOOL OF EDUCATION, ITM UNIVERSITY, GWALIOR, MADHYA PRADESH (APP201660112/8106)
- (vi) G.H. RAISONI UNIVERSITY, CHINDWARA, MADHYA PRADESH (APP201660202-A)

WRO is directed to issue Show Cause Notice in this regard w.r.t. letter No.68759 dated 02.08.2018 received from NCTE Hqrs. The institution should reply within one month."

Accordingly Show Cause Notice was issued to the institution on 11.09.2018.

The institution has submitted reply of Show Cause Notice dt. 11.10.2018. The matter was placed before WRC in its 303rd held on 26th-28th February 2019 and the Committee decided *as under:*-

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made:-

The Show Cause Notice was issued to the institution on 11/09/2018 as per decision of WRC in its 296^{th} meeting.

• The institution has submitted reply of SCN on 11/10/2018.

On perusal of the reply the institution has not submitted following documents:

- The institution has not submitted letter granting approval for the appointment of faculty by the Competent Authority/ Affiliating Body
- The institution has submitted list of staff but not as per NCTE Amendment Regulations 09/06/2017.

Hence, the committee decided to withdraw the recognition for B.A. B.Ed. four years integrated programme from the academic session 2019-2020. under Section 17(1) of the NCTE Act, 1993."

Accordingly, withdrawal order was issued to the institution on 15.03.2019.

The Institution has filed W.P. 3920/2019 of CM APPL. 17741/2019, in the Hon'ble High Court of Delhi at New Delhi against withdrawal order dt. 12.04.2019. The Hon'ble High Court of Delhi passed order dt. 30.04.2019.

The matter was considered by WRC in its 307th meeting held on May 30-31, 2019 and Committee decided as under:-

"In view of the direction of the Hon'ble High Court of Delhi in W.P.(C) No. 3929/2019 order dated 15/04/2019 at point No. 15, decision of WRC about the withdrawal order stands stayed and website be updated accordingly. However, other directions in the decision of the Hon'ble High court stand."
