Vide the present petition, the prayers made by the petitioner are to the effect:-


> (g) issue a writ of mandamus or any other suitable writ or order directing that consequent to the Appeal order dated 11.03.2019 passed by the Appeal Committee remanding the matter back to WRC, the withdrawal order dated20.09.2018 issued by WRC stands quashed and set aside; and/or

(b) issue a writ of mandamus or any other suitable writ, order or direction directing the WRC to comply with and implement the Appeal order dated 11.03.2019 passed by NCTE and to issue a fresh restoration order of Petitioner institution restoring the recognition of D.El.Ed. course which was withdrawn vide its withdrawal order dated 20.09.2018; and/or

(e)issue a writ of mandamus or any other suitable writ, order or direction directing the Respondents

to treat the Petitioner institution for D.E.I.Ed. course as recognized Institution and to display the name of Petitioner institution in the List/Category of recognised institutions for conducting D.E.I.Ed course for the academic year 2019-20 on the website of Respondents; and/or (d) issue a writ of mandamus or any other suitable writ, order or direction allowing the Petitioner institution to participate in the ongoing counselling process for academic session 2019-20

for D.EI.Ed. course; and / or

The petitioner is aggrieved by the impugned order dated 11.3.2019 of the Appellate Committee of the NCTE i.e., the Respondent No.1 vide which in an appeal under Section 18(1) against the order dated 20.9.2018 of the Western Regional Committee under Section 17(1) of the NCTE Act, 1993, vide which the recognition of the petitioner institute for conducting the D.ELEd course was withdrawn from the end of the next academic session, the Appellate Committee remanded back the matter to the WRC to examine the matter in relation to the withdrawal of recognition separately/independently and after ascertaining whether the institute was functioning on the old premises or had shifted to the proposed premises, proposal for which had been refused and to issue appropriate orders as per the relevant provisions of the NCTE Act, 1993.

The petitioner submits that in as much as the matter had been remanded back to the WRC, it was essential and incumbent upon the Appellate Authority to set aside the order of withdrawal.

Reliance has, mer alia been placed on behalf of the petitioners on the verdict of this Court in W.P. (C) No. 4959/2019 titled as HICT Shiksha Mahavidyalaya v. National Council for Teacher Education & Anr.; decided on 8.5.2019 whereby the order vide which the matter had been remanded back to the WRC by the Appellate Authority was clarified to be one which was to be treated as quashing of the order of the WRC and consequently remanding the matter back to the WRC for re-consideration with it having been observed that it is authomatic that quashing of the order in appeal necessarily precedes the remand of the matter to the original authority.

Reliance likewise is made on behalf of the petitioner to similar effect on the verdict of this Court in W.P.(C) No. 5069/2019 titled as Aryan College of Education and Anr. V. National council for Teacher Education and Anr.; with observations therein in paragraph 20 which reads to the effect.

"20 Once the Appellate Committee had remanded the matter for reconsideration to the WRC, the withdrawal order dated 8th January, 2018 (supra) necessarily stood set aside. The petitioners cannot be treated, therefore, as an institution whose recognition stands withdrawn, as on date, though the question of whether to grant recognition to the petitioners-institutions, or not, would have to be decided by the WRC in its de novo proceedings presently pending before it,"

with the directions followed thereby in paragraph 21 thereof which reads to the effect:

"21. The respondent is, therefore, directed to remove, forthwith, from its website, the status of the petitioners, as contained thereon in above extracted para 17 (supra); which makes it appear that the withdrawal order dated

8th January, 2018 (supra), still continue to be in force, and to reflect the appropriate status of the petitioners thereon.";

Reliance has further been placed on behalf of the petitioner on the following verdicts to contend to similar effect:

to which it has been submitted by the learned counsel for the respondent that the respondent No.2 has acted upon the directions of the Appellate Committee and a letter dated 5/10.7.2019 was issued to the petitioner herein calling upon the petitioner to inform whether the petitioner is running the institution from the old premises or has shifted to the new premises and to submit the requisite land documents immediately, to which it has been submitted on behalf of the petitioner that the response thereto has been submitted vide a communication dated 19.7.2019 annexed as annexure P-15 to the petition.

It has thus been submitted on behalf of the respondents that the respondent No.2 has been pursuing the matter pursuant to the order of remand and that the process would take time.

On a consideration of the submissions that have been made on behalf of either side and the refiance placed upon the verdicts in W.P.(C). Nos. 4959/2019, 5069/2019, 5817/2019, 7365/2019, 6789/2019 and 7986/2019, it is apparent that the impugned order of withdrawal dated 20.9.2018 as issued by the WRC F.No. WRC/APPW01234/222055/297th/2018/200208 withdrawing the recognition of the petitioners' institute for conducting D.EI.ED. course in view of the order of remand dated 11.3.2019 of the Appellate Committee i.e., the respondent No.1 has essentially to be set aside and is thus set aside qua the de-recognition of the petitioners' institute for conducting the D.EI.ED. course vide order dated 9.8.2005 and the respondent No.2 is thus directed to upload the correct status of the petitioner on its website in the list of recognized institutes within a

WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely, BHOPAL DEGREE COLLEGE, 393, ASHOK VIHAR, ASHOKA GARDEN, BHOPAL- 462023, MADHYA PRADESH under section 14/15(3)(a) of NCTE Act, 1993 for conducting D.El.Ed. course of two years duration with an annual intake of 50 students vide order dated 09.08.2005.

AND WHEREAS, the institution applied under section 8 (9) of NCTE Regulations 2014, for change of premises from BHOPAL DEGREE COLLEGE, 393, ASHOK VIHAR, ASHOKA GARDEN, BHOPAL- 462023, MADHYA PRADESH to BHOPAL DEGREE COLLEGE, KHASRA NO.120/16, 121/1, 122/2/3, VILLAGE-BILKHIRIYA KALYAN, RAISEN ROAD, DISTRICT-BHOPAL, MADHYA PRADESH on 02.04.2016.

AND WHEREAS, the matter was placed before the WRC in its 282nd meeting held on October 24-26, 2017 and the Committee decided that "...This is a case of shifting. An examination of the file shows that the institution has not submitted the latest CLU with premium receipt, FDRs and the latest staff list approved by the competent authority. Hence, Show Cause Notice be issued on the above points. Reply should be submitted within one month." Accordingly, Show Cause Notice issued on 31.10.2017.

AND WHEREAS, reply received from the institution was placed in 285th WRC meeting held on December 19-21, 2017 and the Committee observed that "...Show Cause Notice was issued to the institution on 30.10.2017 and reply received on 30.11.2017. The institution has submitted CLU premium receipt, FDRs and latest staff list. However, it is seen that the diverted land is much less than the required 3000 sq.mts. for running one unit of B.Ed. and one unit of D.Ed. course. Compliance should be submitted by the institution within one month..." Accordingly, Compliance letter issued on 05.01.2018.

AND WHEREAS, reply received from the institution was placed in 297th WRC meeting held on September 13-14, 2018 and the Committee observed that "...This is a case of shifting. Compliance letter was issued on 29.12.2017 regarding inadequacy of diverted land. The institution replied on 30.01.2018. As per documents submitted by the institution, the land is available at Khasra No.120/16, 121/1 and 122/2. The institution has now stated that it has applied for diversion of Plot under Khasra No.120/20. The land document for Khasra No.120/20 has not been submitted and it is not understood how diversion is sought for this land. The institution has also mentioned about built-up area at Khasra No.123/20 for which land documents are also not available. The institution had asked for six months' time for submission of diversion documents. More than six months' time has passed, the institution has not submitted any document so far. Enough opportunities have been given to the institution to rectify the deficiencies. There has not been any reply to solve the issue of CLU. **Hence, shifting is refused and Recognition is withdrawn from the end of the academic session.**"

NOW THEREFORE, the recognition granted to **BHOPAL DEGREE COLLEGE**, **393**, **ASHOK VIHAR**, **ASHOKA GARDEN**, **BHOPAL- 462023**, **MADHYA PRADESH** for conducting D.El.ED. course vide order dated 09.08.2005 is hereby withdrawn from the end of the next academic session under section 17(1) of the NCTE Act, 1993.

ORDER

In terms of Section 14 (1) of the NCTE Act, 1993 **Bhopal Degree College, Bhopal** had submitted an application to the Western Regional Committee of NCTE for grant of recognition for starting **B.Ed.** of one year duration from the academic session 2003-2004 with an annual intake of 100 students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - (i) The institution has acquired the land for setting up the teacher education institution.
 - (ii) The institution has constructed the building for conducting the course on the above mentioned land.

or

- The institution has made arrangements for conducting the course in rented premises.
- (iii) The institution has created an Endowment Fund of Rs. 5.00 lakhs and a Reserve Fund of Rs. two lakhs.
- (iv) The institution has initiated the process for recruitment of Principal/Head of Department and teachers for the said course.
- Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Bhopal Degree College, Bhopal for B.Ed. of one year duration from the academic session 2003-2004 with and an mal intake of 100 or less students subjects to fulfillment of the following.
 - (a) The institution shall ensure that it gets duly affiliated for this course to the concerned university and all other formalities required by the university are also completed before the commencement of the course and admission of the students to the course and a report to this effect should sent to the Committee.
 - (b) That the institution will ensure that 08 (one Principal and 07 lecturers) faculty members are in position for an intake of 100 or less students before commencement of the course and a report to this effect duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
 - (c) The institution shall within one month of the receipt of recognition convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.
 - (d) The institution shall shift to its own premises within three years from the date of recognition (In case the course is started in rented premises).
 - (e) The institution shall comply with the various other norms and standards as prescribed in the NCTE Regulations.
