ORDER

Whereas, recognition was granted to the Institution, **KARAHAL EDUCATION COLLEGE, VILLAGE GOVERDA KHURD, TAHSIL-KARAHAL, DISTRICT- SHEOPUR, MADHYA PRADESH** for B.ED./D.EL.ED course with an annual intake of 100 students vide order no. WRC/APP3366/254TH/2016/169740-169747 dated. 20.06.2016 for B.ED. course and WRC/NCTE/APP3372/254TH/D.EL.ED/K.M.P./2016/169402-169409 dated. 17.06.2016 for D.EL.ED course.

And whereas, the Institution vide letter dt. 06.06.2019 submitted an application for shifting of premises from **KARAHAL EDUCATION COLLEGE, VILLAGE GOVERDA KHURD, TAHSIL-KARAHAL, DISTRICT- SHEOPUR** to **KARAHAL EDUCATION COLLEGE, VILLAGE- BARAUA NURABAD, POST- BARAUA, DISTRICT-GWALIOR, MADHYA PRADESH.**

And whereas, the matter was placed before the WRC in its 324th meeting held on 23RD TO 24TH & 31ST DEC 2020. The Committee decided as under:-

"In view of above, the Committee decided as under:
VT be constituted for shifting of premises."

And whereas, the matter was placed before the WRC in its 341ST meeting held on 17th to 18th AUGUST 2021 and it was decided:

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines Issued by NCTE from time to time and the Committee decided as under :-

The Institution has submitted an application for shifting of premises. The Institution be directed to submit the following documents:-

- The Institution is required to submit the NOC from the affiliating body for shifting of premises. In case the affiliating body is different at the new premises, then the NOC from the existing and proposed Affiliating body is required to be submitted.

In view of the above, the Committee decided that show Cause Notice prior to withdrawal of recognition be issued to the Institution u/s 17 of the NCTE Act for the existing B.Ed. programme."

And whereas, the matter was placed before the WRC in its 347ST meeting held on 03RD to 5th DECEMBER 2021 and it was decided:

"The institution has complied with all the requirements as per NCTE Regulations and WRC decided to permit the shifting of old premises from **KARAHAL EDUCATION COLLEGE, VILLAGE GOVERDA KHURD TAHSIL KARAHAL SHEOPUR MP** to **New Premises KARAHAL EDUCATION COLLEGE BARAUA NURABAD, POST - BARAUA, DISTRICT- GWALIOR, MADHYA PRADESH.**"

Now therefore, in exercise of the powers vested under section 14(3)(a) of NCTE Act, 1993, permission under clause 8(9) of NCTE Regulation, 2014, is hereby granted for change of premises of **KARAHAL EDUCATION COLLEGE, VILLAGE GOVERDA KHURD, TAHSIL-KARAHAL, DISTRICT- SHEOPUR, MADHYA PRADESH** to **KARAHAL EDUCATION COLLEGE, VILLAGE- BARAUA NURABAD, POST- BARAUA, DISTRICT-GWALIOR, MADHYA PRADESH.**
