The institution has submitted an application for shifting of premises. The institution be directed to submit the following documents is

a. The institution is regulred to submit the NOC from the affiliating body for shifting of premises. In case the affiliating body is different at the new premises, then the NOC from the existing and proposed Affiliating body is required to be submitted.

In view of the above, the Committee decided that show Cause Notice prior to withdrawal of recognition be issued to the institution u/s 17 of the NCTE Act for the existing B.Ed. programme."

And whereas, the matter was placed before the WRC in its 34757 meeting held on 03 to 5th DECEMBER 2021 and it was decided:
