ORDER

Whereas, recognition was granted to the institution, IDEAL COLLEGE, KHASRA/PLOT NO.73/4, VILLAGE - BARAUA, POST OFFICE - ITM COLLEGE, TEHSIL/TALUKA/TOWN/CITY DISTRICT - GWALIOR, PIN CODE - 474009, MADHYA PRADESH for B.ED./D.EL.ED course with an annual intake of 100 students vide order no. WRC/NCTE/APP3484/270/M P/2017/181554-561 dated 08.03.2017 for D.EL.ED course & WRC/NCTE/APP3479/223/270/M P/2017/181771-178 dated 09.03.2017 for B.ED. course.

And whereas, the Institution vide letter dt. 06.06.2019 submitted an application for shifting of premises from IDEAL COLLEGE, KHASRA/PLOT NO.73/4, VILLAGE - BARAUA, POST OFFICE - ITM COLLEGE, TEHSIL/TALUKA/TOWN/CITY DISTRICT - GWALIOR, PIN CODE - 474009, MADHYA PRADESH to IDEAL COLLEGE, SURVEY NO. 343, VILLAGE-JARPURA, POST - SONI, TEHSIL-MENGAON, DISTRICT - BHIND, MADHYA PRADESH.

And whereas, the matter was placed before the WRC in its 324th meeting held on 23rd TO 24th & 31st DEC 2020. The Committee decided as under:-

"In view of above, the Committee decided as under:
VT be constituted for shifting of premises."

And whereas, the matter was placed before the WRC in its 341st meeting held on 17th to 18th AUGUST 2021 and it was decided:

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines Issued by NCTE from time to time and the Committee decided as under :-

The institution has submitted an application for shifting of premises. The institution be directed to submit the following documents :-

- The institution is required to submit the NOC from the affiliating body for shifting of premises. In case the affiliating body is different at the new premises, then the NOC from the existing and proposed Affiliating body is required to be submitted.

In view of the above, the Committee decided that show Cause Notice prior to withdrawal of recognition be issued to the Institution u/s 17 of the NCTE Act for the existing B.Ed. programme."

And whereas, the matter was placed before the WRC in its 347th meeting held on 03rd to 5th DECEMBER 2021 and it was decided:

"The institution has complied with all the requirements as per NCTE Regulations and WRC decided to permit the shifting of premises from old premises IDEAL COLLEGE, Khasra No. 73/4, Village-BaraUA Post office- ITM College Gwalior PIN 474009 to new premises Ideal College, Survey No. 343, Village - Jarpura, Post - Soni, Tehsil- Mehgaon, District- Bhind, Madhya Pradesh."

Now therefore, in exercise of the powers vested under section 14(3)(a) of NCTE Act, 1993 and clause b(v) of NCTE Regulation, 2014, is hereby granted for change of premises of IDEAL COLLEGE, KHASRA/PLOT NO.73/4, VILLAGE - BARAUA, POST OFFICE - ITM COLLEGE, TEHSIL/TALUKA/TOWN/CITY DISTRICT - GWALIOR, PIN CODE - 474009, MADHYA PRADESH to IDEAL COLLEGE, SURVEY NO. 343, VILLAGE-JARPURA, POST - SONI, TEHSIL-MENGAON, DISTRICT - BHIND, MADHYA PRADESH.

With immediate effect for conducting B.Ed. course of two years duration with an annual intake of 100 students.
The institution has move towards a composite institution gradually, as per provision of NCTE Regulations, 2014.
