REFUSAL ORDER

Whereas in terms of section 14/15 of the NCTE Act, 1993, to **RAJEEV GANDHI SADBHAVANA AVM GROMOTHAN SANSTHAN JAIPUR, PLOT NO- 528, STREET NO - BHILAPADA, VILL- NADAUTI, P.O-NADAUTI, TEHSIL- NADAUTI, TOWN/CITY-NADAUTI, DIST- KARALI, RAJASTHAN-322216** had submitted an application to the Western Regional Committee of NCTE applied on for grant of recognition/permission to **S. PATEL STC NADAUTI, PLOT NO-528, STREET NO- BHILAPADA, VILL- NADAUTI, P.O- NADAUTI, TEHSIL- NADAUTI, DIST- KARALI, RAJASTHAN-322216** for **D.EL.ED** Course of two years in 2008/2012.

AND WHEREAS the application was returned back to the application due to the state ban in respect of **D.EL.ED** course .

And whereas, the institution filed a writ petition in the Hon'ble High Court of Delhi at New Delhi and the Hon'ble High Court **W.P No. 1935/2021**, Vide order dated **02.02.2021** .

And whereas, the matter was placed before the WRC in its 337th meeting held on 07th-09th July 2021 and the committee decided as follows :-

The WRC decided that all the applications which have been re-submitted as per directions of the Hon'ble Courts be directed to submit the following documents by way of Show Cause Notice, before processing of their applications by WRC :-

1. Affidavit on Rs. 100 stamp paper from the President / Secretary of the Management duly notarized giving the details of applications pending with NCTE and also the existing courses being run by the management on the same land where this application is proposed, as per format approved by WRC.
2. To submit the proof of submission of initial application to NRC in original, self attested.
3. To submit the proof of rejection of initial application by NRC in original, duly self attested
4. To submit the proof of payment of processing fee at the time of initial application, self attested (photocopy of DD/ Bank Statement / Certificate from Bank etc)

And whereas, the matter was placed before the WRC in its 349th meeting held on 29th - 31st DECEMBER 2021 and the committee decided as follows :-

The original file of the Institution along-with other related documents were carefully examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Show Cause Notice was issued to the institution vide letter dt. 24.7.2021 and reply was received On 11.10.2021

The institution does not fall in the category of composite institution as per Clause 2(b) and 8(1) of NCTE Regulations 2014 hence its application cannot be considered for D.El.Ed. course.

In view of the above, the Committee decided that application of the institution be refused u/s 14/15 (3) (b) of the NCTE Act for D.El.Ed. programme.



Now, therefore, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refused application of D.E.L.ED Course of S. PATEL STC NADAUTI, PLOTNO-528, STREET NO- BHILAPADA, VILL- NADAUTI, P.O- NADAUTI, TEHSIL- NADAUTI, DIST- KARAUJI, RAJASTHAN-322216.

Further, if the institution is not satisfied by the decision, it may prefer an appeal to National Council for Teacher Education, G-7 sector - 10 Dwarka new Delhi - 110075 against this decision under section 18 of NCTE Act 1993 within 60 days of the issue of this letter through online mode, on the NCTE website ncte.gov.in.
