RESTORATION ORDER

WHEREAS, the recognition was granted to the institution namely FIRDOS COLLEGE OF EDUCATION, SURVEY NO. 1810/2 MIN 1, 1810/2 MIN 2, 1811/1 TO 1811/7, VILLAGE: KULEITH, STREET/ROAD: MOTIJHEEL, TALUKA/ MANDAL: GWALIOR, TOWN/CITY: KULEITH, DISTRICT: GWALIOR - 474010, MADHYA PRADESH (APP201660215) for B.A.B.Ed. integrated course vide order no. WRC/APP201660215/9792/B.A.B.ED./M.P./275th/2017/185846 dt. 08.05.2017 for 100 seats from the academic session 2017-2018.

AND WHEREAS, the matter of FIRDOS COLLEGE OF EDUCATION (APP201660208, ID: 9832, D.El.Ed. course) was placed before the WRC in its 278th meeting held on July 25-26, 2017 the committee decided that ".... The institute was given recognition for two units of the D.El.Ed. course from the session 2017-2018 vide recognition order dt. 08.05.2017. This case was considered on the basis of minority status certificate issued on dt. 17.03.2017 in case no. 1335 of 2017. Subsequently the certificate was referred to National Commission for Minority Educational Institution, New Delhi for validation. The National Commission for Minority Educational Institution has vide letter dt. 16.06.2017 has stated that the above referred certificate has not been issued by the commission.

Since this case of forgery, recognition for the D.El.Ed. course is immediately withdrawn. Further the State Govt. be informed about this decision and the name of this College be removed from centralized counseling from the academic session 2017-2018.

Consequently, the B.A.B.Ed. course (APP201660215 ID 9792) is now the only course being run in the institute. This makes the institution a standalone institution which is not permitted as per clause 8(i) of NCTE Regulations, 2014. Therefore, Show cause notice be issued to the institution as to why the recognition granted to this course should not be withdrawn. The reply should be received) within 15 days."

AND WHEREAS, the Show cause notice was issued on 14.08.2017 to the institution u/s 17 (1) of NCTE Act, 1993 giving an opportunity for making a written representation.

AND WHEREAS, the institution has not submitted reply of Show Cause Notice dt. 14.08.2017. The matter was considered by the WRC in its 289th meeting (2nd day) held on March 3, 2018 and the committee decided as under:-

Show Cause Notice was issued to the institution on 14.08.2017. Reply not received so far. Hence, Recognition is refused.

AND WHEREAS, Withdrawal Order was issued to the institution vide order no. WRC/APP2016602015/9792/B.A.B.Ed./289th/{M.P.}/2018/196308 dt. 16.03.2018.

AND WHEREAS, the institution has filed an appeal to NCTE Hqrs against withdrawal order dt. 16.03.2018. The Appellate Authority passed an order dt. 31.10.2018, the operative part of appeal order is as under:-

• After perusal of the memorandum of Appeal, affidavit, documents available on record and oral arguments advanced during the hearing, Appeal committee concluded to remand back the case to WRC with a direction to take further action as per the NCTE Regulations, 2014 and in the light of the Appellate order in respect of D.El.Ed. course and the subsequent decision of the WRC taken in their 297th meeting. In the meanwhile, the order of withdrawal shall be kept in abeyance.

AND WHEREAS, the matter was considered by the WRC in its 300th meeting held on December 17-18, 2018 and the Committee decided as under:-

This is a case of appeal. The Appellate Authority vide order dated 31.10.2018 has remanded the case to WRC with a direction to take further action as per the NCTE Regulations, 2014.

WRC has decided that this case should be put up in conjunction with File No.APP201660215/ ID:9792 (D.El.Ed. course) in the next meeting.

AND WHEREAS, the matter was again placed in WRC in its 303rd meeting held on February 26-28, 2019 and the Committee decided as under:-

• The committee perusal the operative part of appeal order dated 31/10/2018 of B.A B.Ed. programme "wherein appellate authority has remanded back the case to WRC to take further action as per NCTE Regulations 2014. In the light of appellate order in respect of the D.El.Ed. course and subsequent decision of the WRC taken in their 297th meeting".

• The institution is required to submitted original Minority certificate dated 3/11/2017 and 17/03/2017 and notarized copy of both the certificate along with affidavit from the Secretary of the applicant Society verifying the content of the Minority Certificate dated 3/11/2017 and 17/3/2017.

Hence, show cause notice be issued under Section 17 of the NCTE Act, 1993 to the institution to submit the from the date of issue of show cause notice failing which the recognition will be withdrawn.

AND WHEREAS, Show Cause Notice was issued to the institution on 12.03.2019.

AND WHEREAS, the institution has not submitted reply of Show Cause Notice.

AND WHEREAS, the matter was considered by the WRC in its 307th meeting held on May 30-31, 2019 and the Committee decided as under:-

The Show Cause Notice was issued to the institution vide letter dated 12/03/2019. The
institution has not submitted reply of Show Cause Notice.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for E.A. B.Ed. with effect from the end of the academic session next following the date of communication of the said order.

AND WHEREAS, Withdrawal order was issued to the institution on 06.06.2019.

AND WHEREAS, the institution has filed W.P. (C) 7070/2019 in the High Court of Delhi, Bench at New Delhi passed an order dt. 05.07.2019.

AND WHEREAS, the matter was considered by the WRC in its 309th meeting held on July 23-26, 2019 and the Committee decided as under:-

The committee considered case in the light of the order dated 05/07/2019 passed by the Hon'ble High Court of Delhi in W.P. No. 7070/2019 .

The institution needs to submit certified copy of minority certificate issued by the competent authority within 30 days to process the case further.

AND WHEREAS, Comliance letter was issued to the institution on 29.07.2019.

AND WHEREAS, reply received from the institution and the matter was considered by the WRC in its 336th meeting held on March 24-25, 2021 and the Committee decided as under:-

The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:-

The Committee respectfully considered the order dt 05.07.2019 passed by the Hon'ble High Court of Delhi and the reply submitted by the institution, the Committee decided that the Recognition be restored and the order be issued to the Institution FIRDOS COLLEGE OF EDUCATION, KHASRA NO 1810/2 MIN 1, 1810/2 MIN 1, 1811/2 MIN 2, 1811/1 TO 1811/7, VILLAGE KULEITH, STREET/ROAD MOTIJHEEL, TOWN/CITY KULEITH TALUKA/MANDAL/ DISTRICT GWALIOR 474010, MADHYA PRADESH for B.A.B.ED programme for 100 students.
