#### RESTORATION ORDER

WHEREAS, recognition was granted to the institution namely FIRDOS COLLEGE OF EDUCATION, KHASRA NO - 1810/2 MIN 1, 1810/2 MIN 1, 1811/2 MIN 2, 1811/1 TO 1811/7, VILLAGE-KULEITH, STREET/ROAD-MOTIJHEEL, TOWN/ CITY-KULEITH, TALUKA/MANDAL/DISTRICT- GWALIOR, PIN CODE - 474010, MADHYA PRADESH vide Order No. WRC/NCTE/APP201660208/9832/222/275th/D.El.Ed/{M.P.}/2017/185836 dated 08.05.2017 for D.El.Ed. course of two years duration with an annual intake of (two basic units of 50 each) of 100 students.

AND WHEREAS, Madhyamik Shiksha Mandal Bhopal vide letter dated 19.05.2017 has forwarded a complaint received against the institution.

AND WHEREAS, letter dated 25.05.2017 was issued to the National Commission for Minority Educational institutions, New Delhi for validation of minority certificate submitted by the institution.

AND WHEREAS, reply received form the National Commission for Minority Educational Institutions, New Delhi was placed before WRC in its 278th meeting held on July 25-26, 2017 and the Committee decided that "...The institute was given recognition for two units of the D.El.Ed. course from the session 2017-2018 vide recognition order dt. 08.05.2017. This case was considered on the basis of minority status certificate issued on dt. 17.03.2017 in case no. 1335 of 2017. Subsequently the certificate was referred to National Commission for Minority Educational Institution, New Delhi for validation. The National Commission for Minority Educational Institution has vide letter dt. 16.06.2017 has stated that the above referred certificate has not been issued by the commission. Since this case of forgery, recognition for the D.El.Ed. course is immediately withdrawn. Further the State Govt. be informed about this decision and the name of this College be removed from centralized counseling from the academic session 2017-2018.

Consequently, the B.A.B.Ed. course (APP201660215 ID 9792) is now the only course being run in the institute. This makes the institution a standalone institution which is not permitted as per clause 8(i) of NCTE Regulations, 2014. Therefore, Show cause notice be issued to the institution as to why the recognition granted to this course should not be withdrawn. The reply should be received within 15 days."

AND WHEREAS, the recognition was withdrawn to the institution namely FIRDOS COLLEGE OF EDUCATION, KHASRA NO - 1810/2 MIN 1, 1810/2 MIN 1, 1811/2 MIN 2, 1811/1 TO 1811/7, VILLAGE-KULEITH, STREET/ROAD-MOTIJHEEL, TOWN/ CITY-KULEITH, TALUKA/MANDAL/DISTRICT- GWALIOR, PIN CODE - 474010, MADHYA PRADESH vide order No. WRC/APP201660208/222 /278<sup>th</sup>/{M.P.}/2017/188217 dt. 08.08.2017 for D.El.Ed. course.

AND WHEREAS, the institution has filed an appeal to NCTE Hqrs against withdrawal order dt. 08.08.2017. The Appellate Authority passed an order dt. 16.05.2018 and operative part of appeal order is as under:-

After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the committee concluded that the matter deserved to be remanded to the E.R.C. W.R.C. with a direction to issue a show cause notice to the appellant and take further action as per

the NCTE Regulations, 2014. The W.R.C. may keep in view the provisions contained in Clause 7 (3) of these Regulations. The appellant is directed to forward to the W.R.C. the Minority certificate dt. 03/11/2017, submitted in the appeal, within 15 days of receipt of the orders on the appeal. In the meanwhile, the order of withdrawal shall be kept in abeyance.

AND WHEREAS, the matter was considered by the WRC in its 293<sup>rd</sup> meeting held on June 12-14, 2018 and the Committee decided as under:-

This is a case of Appeal. The WRC had withdrawn the recognition of the D.El.Ed.course on the basis of the letter received from the National Commission for Minority Educational Institutions dated 16.07.2017 stating that the Minority Certificate submitted by the Institution has not been issued by the Commission. The Withdrawal order was issued to the institution on 08.08.2017.

The institute went in Appeal and the Appellate authority videsorder dated. 16.05.2018 asked to WRC to issue a Show Cause Notice and further action as per Regulations, 2014 especially clause 7(3).

Show Cause Notice be issued to the institution as to how it has submitted a fake document initially and another document after the Withdrawal order. A reply should be received within one month. On receipt of the reply, further action will be taken.

At the same time, both the Minority Certificates should be sent to the National Commission for Minority Educational Institutions for validation.

AND WHEREAS, Accordingly, Show Cause Notice was issued to the institution dt. 09.07.2018.

AND WHEREAS, the institution has submitted reply on 16.07.2018 & 21.07.2018 of Show Cause Notice.

AND WHEREAS, the matter was considered by the WRC in its 295<sup>th</sup> meeting held on July 30-31, 2018 and the Committee decided as under:-

This is a case of appeal. The Appellate Authority vide order dated 16.05.2018 has remanded the case to WRC for further processing the application.

It directed the institution to forward to the WRC the minority certificate dt. 03.11.2017 within 15 days. The institute has submitted the required certificate.

The WRC considered the case and issued Show Cause Notice to the institution regarding the lapse connected with the minority certificate. The institute has replied to the Show Cause Notice.

However, the restoration of the course will be considered as soon as the reply of the Show Cause Notice issued for the B.A. B.Ed. course (APP201660215/ ID 9792) is received.

AND WHEREAS, Accordingly, a letter was issued to the institution dt. 09.08.2018.

AND WHEREAS, the institution has not submitted reply of letter dt. 09.08.2018.

AND WHEREAS, the matter was considered by the WRC in its 297<sup>th</sup> meeting held on May September 13-14, 2018 and the Committee decided as under:-

 Minority certificate was referred to the National Commission for Minority Educational Institutions, New Delhi which clarified that they have not issued the minority certificate dated 17.03.2018. Recognitison withdrawn vide order dated 08.08.2017. The institution went in appeal. The Appellate Authority vide order dated 16.05.2018 directed the WRC to accept the new minority certificate. Therefore, the National Commission for Minority Educational Institution, New Delhi has finally confirmed the new minority certificate vide letter dated 23.08.2018.

### The case should be processed further from whatever stage it was earlier.

AND WHEREAS, the institution has submitted reply dt. 21.12.2018.

AND WHEREAS, the matter was considered by the WRC in its 303<sup>rd</sup> meeting held on February 26-28, 2019 and the Committee decided as under:-

 As per appeal order dated 16/05/2018 "wherein appellate authority has remanded back the case to WRC to take further action as per NCTE Regulation 2014. Appellate authority also directed to forward the copy of Ministry certificate dated 03/11/2017 submitted in appeal with 15 days receipt of the order of the appeal.

The committee perused the file in light of NCTE Regulations 2014 as well as directions of

appellate authority dated 16/05/2018 and has observed as under:

• The institution has submitted online application on 29/06/2016. The Minority Certificate

 As per decision of 293<sup>rd</sup> meeting of WRC at the same time both the minority certificate should be sent to National commission for Minority Educational Institutions for validation, the WRC vide letter dated 09/07/2018 has written a letter to Minority Commission for validation of both the certificate.

 However, Minority Commission vide its letter dated 30/08/2018 has sent verification of only one certificate mentioned at Sr. No. 9 of the letter with the case no. 318 of 2017 along

with its date of issue as 03/11/2017.

• Letter dated 23/08/2018 of Minority Commission has not mentioned about the certificate "of case No. 1335 of 2017 dated 17/03/2017."

 Therefore, at a time of application the institution has submitted Minority certificate having case No. 1335 of 2017 dated 17/03/2017 has not been verified by the Minority Commission.

 The institution is required to submitted original Minority certificate dated 03/11/2017 and 17/03/2017 and notarized copy of both the certificate alongwith affidavit from the Secretary of the applicant Society verifying the content of the Minority Certificate dated 03/11/2017 and 17/03/2017.


Hence, show cause notice be issued under Section 17 of the NCTE Act, 1993 to the institution to submit the from the date of issue of show cause notice failing which the recognition will be withdrawn.

AND WHEREAS, Show Cause Notice was issued to the institution on 12.03.2019.

AND WHEREAS, the institution has not submitted reply of Show Cause Notice.

AND WHEREAS, the matter was considered by the WRC in its 307<sup>th</sup> meeting held on May 30-31, 2019 and the Committee decided as under:-

 The Show Cause Notice was issued to the institution vide letter dated 12/03/2019. The institution has not submitted reply of Show Cause Notice.



Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for D.El.Ed. with effect from the end of the academic session next following the date of communication of the said order.

AND WHEREAS, Withdrawal order was issued to the institution on 06.06.2019.

AND WHEREAS, the institution has file W.P(c) 7118/2019 & CM APPL. 29620-29621/2019. In the High Court of Delhi at New Delhi against withdrawal order dt. 06.06.2019. The Hon'ble High Court of Delhi passed an order dt 05.07.2019.

AND WHEREAS, the matter was considered by the WRC in its 309th meeting held on July 23-26, 2019 and the Committee decided as under:-

The committee considered case in the light of the order dated 05/07/2019 passed by the Hon'ble High Court of Delhi in W.P. No. 7118/2019 .

The institution needs to submit certified copy of minority certificate issued by the competent authority within 30 days to process the case further.

AND WHEREAS, accordingly a Minority Certificated was issued to the institution on 29.07.2019.the institution has submitted reply received on 21.11.2019.

AND WHEREAS, the matter was considered by the WRC in its 336th meeting held on March 24-25, 2021 and the Committee decided as under:-

The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that: -

The Committee respectfully considered the order dt 05.07.2019 passed by the Hon'ble High Court of Delhi and the reply submitted by the institution, the Committee decided that the Recognition be restored and the order be issued to the Institution FIRDOS COLLEGE OF EDUCATION, KHASRA NO 1810/2 MIN 1, 1810/2 MIN 1, 1811/2 MIN 2, 1811/1 TO 1811/7, VILLAGE KULEITH, STREET/ROAD MOTIJHEEL, TOWN/CITY COLLEGE TOWN/CITY D.EI.Ed programme for 100 students.

NOW THEREFORE, the recognition of FIRDOS COLLEGE OF EDUCATION, KHASRA NO 1810/2 MIN 1, 1810/2 MIN 1, 1811/2 MIN 2, 1811/1 TO 1811/7, VILLAGE KULEITH, STREET/ROAD MOTIJHEEL, TOWN/CITY KULEITH TALUKA/MANDAL/DISTRICT GWALIOR 474010, MADHYA PRADESH for conducting D.El.Ed course with an with an annual intake of 100 (SEC) (two basic Units of 50 students each) is permitted to Restoration order from the withdrawal Order WRC/APP201660208/9832/307th/M.P/2019/203826-203835 was Dated 06.06.2019 with an annual intake of 100 students (two basic units).
